#### MARION TOWNSHIP SUPERVISORS MEETING December 14, 2010 at the Township Building

**Present:** Jack Aberegg, Ray Gutshall, Ken L. Roan and Ellie Trulick

Guests: Jerry McCloskey, Levi Fisher, Brian McCauley, Tim Weight, and Orie Hanley

Vice Chairman Gutshall called the meeting to order at 7:00 p.m. followed by Pledge of Allegiance

Roan made a motion to approve the minutes as printed Aberegg 2<sup>nd</sup> Aberegg- Yes Gutshall – Yes Roan - Yes

### **Public Comments:**

Brian McCauley stated that PennDOT would be re paving the area on Rt 26 that was grooved along the burms. Brian stated that if we get to be a member of the CCMPO it would probably not be until June. Another meeting will be held and then the complete board must approve membership and then the by-laws will need to be changed. Gutshall stated Option B is we pay and have 1 vote. Option A is Walker, Marion and Bellefonte Borough all together and chooses someone to vote at meetings. If a Township issue arises all three would need to get together to decide how to vote. This option he feels is the way to go as the fee would be reduced to Marion Township. Options need to be discussed further. No tax increase will be needed till later in June if at all per McCauley's recommendation sent to the Supervisors item 11.

McCauley also said that the packet received from Ken Bean of Bellefonte School District is just the information for what will be done by State College School District. (See Items 8 below)

#### **Old Business:**

1. Fire Service Task Force \$100.00 check to be sent to Benner Township. This has not been done due to questions about receiving invoices before the \$100.00 is sent to Benner Township. Roan to discuss at next Fire Tax Force meeting. Aberegg will purchase weather radio for use at the office. The FEMA courses 100 and 700 must be taken by the end of December 2010. If there were a disaster and the complete board and the secretary/treasurer have not completed these courses we have the possibility of not receiving funding. Gutshall asked EMC McCloskey to e-mail the information again to him.

- 2. Park & Rec Roan Family donation of time and mileage for Park Grant was mentioned. The Roan family has worked 96 hours toward the 2000 volunteer hours required by the park grant application. Also they have donated 143 miles. Fifty-Six bottles of soda was sold last month. Soda is not selling well right now. Rest rooms have been closed for the winter. A bill was received from Hartzell Contracting for \$3700.00 for additional charges for their installation of the playground equipment at the Park. Aberegg made a motion that Supervisor Roan contact Ely Company and see what we can work out to bring before the board at our next meeting. At which time we may then turn the matter over to our attorney. - 3. Zoning Report for November 2010 Hildebrand and Sharif are the only two outstanding issues right now. Tim has been in contact with both of them. Roan stated that Hildebrand is still not compliant with the septic tank pumping Ordinance. Aberegg made a motion to send Hildebrand to the magistrate. - 5. Head Roadmaster Report Brian Hovies letter regarding availability to work for Marion Township was received.

Aberegg stated it is himself or his designate. McCauley stated the Head Roadmaster should look into a camper that is parked on Two Mile Road. Roan and Aberegg will check on this on the way home. HRM Aberegg asked how we are to determine the Right of Ways for residents. Much discussion on how to make this determination. Roan will bring up at Planning Commission for Louise to help figure this out.
