

**GANGES TOWNSHIP BOARD
REGULAR MONTHLY MEETING
MINUTES OF OCTOBER 13, 2020**

Barry Gooding reported the Planning Commission meeting was cancelled in Sept. The next meeting will be October 27. Transfer Station has a new sign that was installed and there was increase in price.
