## **IGSA** Update

## Intergovernmental Support Agreement

- Up to \$15M (over 10 years) approval authority delegated to Installation Commanders
- IGSA are exempt from the FAR
- Contracting Officers warranted at appropriate level are responsible for administration
  - Encouraged to use FAR Part 12 clause (or similar) to protect interest
- IGSA award should be on competitive basis
- Contracting Officers should consider state and local communities during market research



- TCPI WGs are dynamic and evolved as needed
- New Work Groups have been stood up while the scope of others have evolved
- Strategic Pause
  - Designated Work Groups will remain "ready for duty" should needs arise
  - No longer a continued requirement for the Work Groups to meet or present updates at TCPI / CPP meetings
- Final summary of successes



#### Eco-Tourism & Environmental

- Coordinated with Eglin AFB to complete two Concrete to reef (C2R) projects.
   One in 2015 and one in 2017. Planning for another deployment in 2020. A total of four locations were created. Heavily visited by divers and anglers.
  - Eglin is able to dispose of used target and concrete material for free. Okaloosa County received free reef materials.
- Worked closely with Matrix design group to develop a working document to guide us towards the creation of an underwater military tribute. Input from the military installations was necessary to develop this document and the final creation of this reef site will require close coordination and input from the military installations.
- Worked with numerous entities and installation personnel to develop plans/proposals College pond. The significance of this project was as it related to the threatened species – Okaloosa Darter. It has the potential to delist this species which is a huge win for conservation purposes. Delisting a species is not common action.
- Early accomplishments (before the current chairs were involved) included coordination for day use permits for area (Eglin) beaches as well as comments and information gathering for a bike/walking path across Okaloosa Island.

#### WG Structure

 Feb 2018\_Enhanced focus resulting in name change from 'Infrastructure & Shared Services' to 'Transportation & Infrastructure', and updated co-chairs

#### Purpose

- Seek partnerships with an emphasis on efficiency improvement, resource utilization and cost effectiveness
- Transportation Improvements: Identify initiatives that would improve traffic flow (vehicular, multi-modal, pedestrian, etc.) and decrease military response time
- Stormwater: Potential to partner on water quantity and quality projects to minimize stormwater runoff impacts
- Reclaimed Water: Partnership between Niceville, Okaloosa Water & Sewer and Eglin AFB for the utilization of reclaimed water
- Activities or services that are performed by two or more entities should be considered to see if a savings potential exists



## Strategic Pause; Continued

- Crestview Bypass Initiative
  - Brought together group of Community and Base leadership to collectively and successfully advocate for Triumph Gulf Coast funding
  - Triumph awarded \$64m
    - PJ Adams Phases 1–3 Widening
- Reclaimed Water Main
  - 10-mile main to service City of Niceville, lateral to service Eglin AFB, and wastewater treatment plant equipment to produce reclaimed water. \$10.5 m project.
- Brought awareness to the existing transportation planning process and various projects in the region
  - Highway 98 Widening
  - Hurlburt Field egress of main gate onto Hwy 98
  - SR 85 Widening



## Real Property

- Developed beach club/Destin bridge options in coordination with the Environmental group (still in work)
- Supported Sept 2018 EUL forum in Sandestin
- Conducted EUL survey to determine local interest in EUL (currently pursuing parcel adjacent to REEF as next EUL, survey results will support request package)
- Provided AF community partnerships director tour of Emerald Breeze EUL
- Accomplished reclaimed water easement and MOU
- Provided informational conduit from installation to community concerning Eglin Real Property initiatives
- Briefed EUL/TCPI to ADC Oct 2016 conference
- Vetted EUL proposal near Eglin Beach Club; not pursued
- Vetted the Airport Munitions Building; not pursued

Challenge/Demand/Need	<ul> <li>Eglin Air Force Base and Hurlburt Field report being at capacity</li> <li>Significantly fewer homes post privatization as compared to pre-privatization</li> <li>A higher percentage of military families are required to live in the civilian community</li> <li>Additional demand placed on the community's housing supply</li> </ul>

# Childcare Facility Task Force



- Initiated as an ad hoc task force in January 2019 following discussion in which shortage of adequate childcare for military members was brought to the attention of TCPI leadership by installation command
- Mission Statement
  - To identify childcare facility demands and possible solutions for both the military and civilian community families
- Goals / Objectives
  - Provide secure accredited childcare per DoD guidelines
  - Provide affordable quality childcare
  - Reduce required commute time to childcare facilities
- Tasks
  - Quantify the current demand/need
  - Identify and catalog the current local childcare facilities
  - Make recommendations based on findings

Recommendations and Next Steps	<ul> <li>Consider Family Child Care licensing with initial background check approvals with increased unannounced inspections to shorten licensing time.</li> <li>Request representation of military childcare on the Florida's Early Education Advisory Council as part of federal Preschool Development Grant awarded to the Florida Department of Education Office of Early Learning. (Request made – pending notification of grant renewal and next steps.)</li> <li>Consider childcare programs contracted with the Early Learning Coalition with higher Classroom Assessment Scoring System (CLASS) scores for military childcare program approval.</li> <li>Kay Rasmussen invited to report out on a Childcare Panel at the National Association of Defense Communities summit in San Antonio, TX in February</li> </ul>
