FINANCIAL STATEMENT

Larry Brown reviewed financial statement. Larry then gave an update on CD rates. Rates right now are at 1.85%. He met with O'bannon bank and they offered a 7 month CD for 5.2% and 12 month CD for 5.00%. Larry looked at all of funds and all departments, so he could figure out how much money the city can afford to put into CDs. Larry believes it would be a good idea to invest in CDs. Need to do a resolution saying who can invest the money and who can get it back out. Since just getting started, do a CD ladder, so every few months you have a CD coming due. As they start maturing they will be coming due and then you always have the money, without worrying about taking money out with a penalty.

Icenhower asked how many CD's are you talking about?

Larry said possibly 1 CD for Park and 8 CD's minus the park. Danderson says that Roe, him and Icenhower need to discuss.

EMERGENCY MANAGEMENT

Kris Bone spoke about the new and updated plan for the city. The 2023 version was needed for the grant. All of the required trainings are available online. However, some training is due within the first 24 months, so next year, Kris and Mark will be traveling to in-person training classes that are close to the vicinity.

Kris also talked about the Heritage Festival and the number of people that attend. There is an Event action plan, but it's too late this year to put it in place. Next year she would like to take the opportunity to use the action plan. She believes that the festival will get bigger in numbers because of COVID being past.

Beaty said that the Historical Society needs to be given more information about the Event Action Plan, as they have never had it before.

POLICE DEPARTMENT

Ewbank updated that a lot has happened in the last 4 weeks. They sold a vehicle and got more money out of it that they planned. Police department lost Jeff Witt, Kris Bone and Ben McMains to SRO positions. He said they had some good applicants for the open positions and did roughly 24 interviews. They picked 3 of the top candidates and hired them. One starting next week and the other 2 do not graduate until December.

Chief Ewbank stated the Fair Grove PD is using a 2017 policy and procedure manual. It is outdated as there have been a lot of changes in the past 6 years. Required policies are not in the manual and it can't easily be updated. Talking with other Police Chiefs in Southwest Missouri, most use Lexipol. Lexipol would cost around \$5,000 to put in place. The Chief says he will have around \$15,000 left from salaries at the end of the year due to being understaffed, as well as extra money from vehicle that was sold. He also submitted paperwork for a grant to pay for computer for a savings of \$3,000 or \$4,000. Chief Enderle made some good updates verbally, but not in writing. Chief Ewbank feels that not having updated policies and procedures could be a recipe for disaster.

Icenhower says you need to have I's dotted and T's crossed. Danderson asked how long are you tied to it? Ewbank says that it is an annual renewal. Danderson asked if it is something that needs to be bid? Ewbank doesn't know of another company. Ewbank says that this year would be around \$2,900 then it goes up around \$800 per officer. This was the price quoted through June 2024. Lexipol make the policies and procedures specific to Fair Grove.

Danderson says that the Policy and Procedures that the city is using right now have never been approved by the City. Danderson asked if this would you be considered a sole proprietor bid? Ewbank says yes.

Lord stated that it is an insurance policy for the City. It's expensive, but worth it as there have been lots of changes in the police world. We have to and need to do something. I do not know of another option. In my opinion it is worth it.
