

C.I.Q.M.A. Zero Tolerance Policy

Welcome to Mini Indy! We are very proud of our facilities, race track, club officials, members and our family atmosphere. To ensure that your family's experience here is a positive one, we have instituted a ZERO TOLERANCE POLICY. Please review the violations below and make sure that everyone associated with your race team is familiar with them.

This policy will be strictly enforced and all decisions will be made by the Mini Indy Board of Directors.

	Violation/Action	Suspension Term*
1	Deliberately Damaging, Destroying or Defacing Mini Indy Property and Facilities.	(1) Year Plus Cost of Damages
2	Being under the influence of drugs or alcohol during racing conditions (ie. Driver/Handler Meeting to Tech Completion).	(6) Months – 180 Days
3	Making any physical/verbal threat or contact to any person at Mini Indy facilities (including drivers).	(1) Month and up to 4 races
4	Throwing object in Pit Area or Hot Chute.	(2) Race Weekends
5	Ignoring instructions from a Track Official (Driver).	(1) Race Weekend. Driver is done for the day and receives a DQ for that day
6	Ignoring instructions from a Track Official (Handler).	(1) Race Weekend and handler is done for the day
7	Violating Mini Indy Rules and Regulations. Including, but not limited to; Smoking in non-designated areas, violating Mini Indy practice policy.	(1) Race Weekend
8	Excessive Yelling, Comments, or Obscenities directed at Track Official, Judge, Handler, or Driver.	(1) Race Weekend
9	Driver deliberately hitting another driver while on track or in hot chute	Done for the day & DQ from class (Note: Driver Only)
10	Driver making a hand gesture to track official.	Done for the day & DQ from class (Note: Driver Only)
11	Any disrespectful conduct toward the Chief Steward and/or Race Official.	Done for the day & DQ from class (Note: Driver and Handler)
12	Any social media posts listing the track(s), any track officials, family name, driver name, pictures or video criticizing any of the above.	(1) Race Weekend

***Suspension Terms**

- The Mini Indy Board can choose to suspend member, driver and/or handler at Board's discretion.
- All driver suspensions are for the individual driver only.
- All suspension terms begin the following race date on the schedule or as noted above.
- All suspensions will be approved by the Board of Directors.
- Suspension term will be determined by the Board Members.
- Suspension term can carry over to the next calendar year.
- Multiple violations/actions within a 12 month period will receive a suspension term.
- All suspension terms may be adjusted due to the severity of the violation by the Board of Directors.
- Written notification of suspension term will be sent and postmarked within 5 days of violation.
- Appeals must be received in writing within 7 days of receiving written suspension notification.
- Any DQ or suspension in reference to ZTP will not be allowed to be used as a "drop" in points.
