All references to the Whatcom Demo Derby Club and indemnifications extended to the Whatcom Demo Derby Club herein shall include the Whatcom Demo Derby Club itself, all Whatcom Demo Derby Club agents, employees, officers and directors of the Whatcom Demo Derby Club as well. If a court of competent jurisdiction rules invalid and/or unenforceable any of the provisions or interpretations of this indemnity clause, each of such provisions or interpretations ruled invalid or unenforceable shall be disregarded, but the remainder of this indemnity provision shall be given full force and effect.
