#### New Business:

a. Klocke reported that all of the sewer segments had been lined that could be done prior to the point repairs being completed. SAK is in the process of obtaining bids for the point repairs. The Council also discussed a segment that SAK is unable to line and options of doing it now or later.

Klocke also gave his report on the culvert on Emerson Hough. The bottom of the culvert is rusted out. Water is flowing down underground instead of out of the pipe. Klocke submitted a cost estimate to Clark for the replacement of the culvert.

  2013-002 amending provisions pertaining to installment payment of cost of abatement. Upon roll call vote, motion carried unanimously.
