Our qualified monitors have received Child Abuse Identification and Report Training, and comply with section 5.20 of the California Rules of Court. All monitors have CPR and First-Aid Training. The following rates are for a Monitored Visitation by a qualified Monitor, based upon the length of visitation. We also have Licensed Mental Health Professionals and off-duty Policemen available for more difficult situations. Call us for more detailed information.

Reports are available on request at a cost of \$75.00 per report. Reports required in 10 days cost \$100.00 and less than 3 days cost \$150.00. Declarations requested with two weeks' notice cost \$175.00; Less than two weeks' notice costs \$200.00. (Reports include a copy for each parent, the Attorneys, minor's Counsel and DCFS Social Workers.)

Services Rates and Fee

- **Transportation fees** vary between \$20.00 and \$50.00 based upon location of the visitation. (Off site visitation services only). **Initial:** _____
- If **Monitor's vehicle** is being used for transportation during the visitation an additional transportation fee of \$0.65 per mile will be charged. **Initial:** _____
- **Court Professional Witness** fee of \$500.00 half day and \$1000.00 full day, plus parking and transportation expenses apply when the Monitor or staff has been subpoenaed to appear in Court. Total fee must be received in office 48 hours prior to the Court Date. **Initial:** _____
- **Copies of monitoring reports** are available with a 7-day notice, for a cost of \$20.00 per report; with less notice, report will cost \$100.00. **Initial:** _____
- **Legal Holidays** Visitations (New Year's Eve, New Year's Day, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day) will be charged at Holiday Rate. **Initial:** _____
- **72 hour notice** is required for all scheduled visits, with payment made directly before the visit. Last minute and same-day services will incur an additional 15% charge. **Initial:** _____
- **Cancellation** of a scheduled visit with less than a 48 hour notice will result in a cancellation fee equivalent to that scheduled visit fee, being the responsibility of the party cancelling the visit. **Initial:** _____
- **Visit Termination** during the course of the scheduled visitation hours by the monitor, due to any rule violation or misconduct, will result in the Monitored Party being responsible for paying the scheduled visit fee. **Initial:** _____
- **Special Events.** Parents who wish to take their child to special events or places that require admission charges (e.g., movies, Disneyland, sporting event, etc.) will be responsible for the admission expenses for the Monitor. **Initial:** _____
