# 2. ROLL CALL - DETERMINATION OF A QUORUM

a. APPROVE DIRECTOR ABSENCES AS EXCUSED/UNEXCUSED President Brinkley, Sauer, Anderson, Miller, Eggleston, LaFountain, Rourke and Director Keys were present and Adam Dummer was absent. Director Sauer moved to excuse Director Dummer's absence, seconded by Director Miller and approved unanimously.

# 4. COMMENTS FROM ASSOCIATION MEMBERS AND/OR PUBLIC

Director Eggleston commented that she thinks the fair should have a float in the parade. Mike said he thinks he is too busy personally but if we could recruit some help it might be possible. Donna Grisham mentioned that last year the fair did place first place. Discussion ensued. Jack mentioned that we will need volunteers for the 4<sup>th</sup> of July parade in Weaverville. Discussion ensued.

## 5. CONSENT AGENDA & MINUTES

APPROVE June 15, 2017 AGENDA and May 18, 2017 MINUTES

Director Miller asked to have the minutes updated for May 18, 2017 to reflect that Director Dummer was present rather than excused for his absence for that meeting.

Director Eggleston moved to approve the May 18, 2017 minutes with the understanding that Director Dummer would be listed as present. Director Anderson seconded and approved unanimously.

#### 6. APPROVE MAY 2017 FINANCIAL REPORTS

Director Anderson said it all looked good and balances. Director Rourke moved to approve the May 2017 financial reports, seconded by Director Sauer and approved unanimously.

#### 8. CEO'S REPORT

#### a. Grants

Mike informed the board that TCFA was approved for a \$400 grant from Trinity Trust for Art and craft walls/racks. We are now phasing out the old wooden art stands as we get new ones. In addition to this grant, the Hayfork Chamber of Commerce also gave a TOT grant of \$1597.62 to assist the fair with advertising expenses. Discussion ensued. Mike submitted a grant request to The Art Place to assist us in building the Maker's Place and that was turned down.

#### b. **DFM**

CFSA is in the process of placing bid packages out there for the work. The Contractors came out for a walkthrough on June 20<sup>th</sup> and I have asked for the work to begin immediately following Bigfoot BBQ in September. Mike explained that we may not get everything we asked for but a good amount of it will be worked in. Director Sauer asked if the floors will be covered and Mike replied no. He then went on to say that as of now, we are no longer a commercial kitchen although we have not been contacting yet. Discussion ensued. Director Anderson asked what type of costs are associated with bringing the kitchen back up to code and Mike said he did not know at this time. Discussion ensued. Director Keys said he does have experience in this arena and he would like to help. Discussion ensued.

#### c. School

Mattole came out to see the 4H building and said there are some things that need attention such as the bathrooms but overall, they said overall things looked good. Mattole is now limited to their current enrollment of only 25 students' due to a law that requires them to have a certain percentage of students in their home county. Discussion ensued. Mike then said we will have to wait and see how it goes.

## d. Concert Sign-up Sheet

Mike said for this concert we won't need as many volunteers as the last but we do have key positions that need to be filled. Probably 6-7 volunteers will be needed for this one. Director Keys said he would like to see more dance at some point and possibly involve kids a bit more. Discussion ensued. Mike then said that Rotary, Terry Nagle and Curvy Roads Kegged Wines will be there again for this concert.

## e. **Q&A**

President Brinkley mentioned that something that the TCFA board will need to look at is the amount of steer entering the livestock auction this year. He is concerned that all of the money will be spent on steer which will not leave much money for the smaller animals when they are auctioned. Discussion ensued. Jennilea Brookins said that when she goes to the fair, she knows she can't afford a steer but she can afford and usually purchases two smaller animals. Discussion ensued.

Mike mentioned the smoking of marijuana at the fairgrounds and after I read an article Sandy Bechtold gave me, it sounds as if the state might treat marijuana as they do with alcohol. President Wallace said that it shouldn't affect TCFA as we currently have a smoking policy in place. Discussion ensued. Mike said that he would like to see an ad hoc committee and he would like to be the chair or at least on the committee. Discussion ensued.

Mike asked the board to make a date for his evaluation. Discussion ensued. All board members agreed that June 21, 2017 at 4:45PM would be the time to complete the evaluation.
