Thank you for your application to this year's festival. We are honored to be hosting this event. We are looking forward to working with all of our return vendors and excited to welcome our new vendors!

Please read the following details carefully:

- **SITE FEE:** The site fee is \$300 for the 2 days. The site fees are the same if you have a truck, cart, trailer or tent set up. Full site fee payment is due at the time of application filing. **Once your space has been reserved for the festival no refunds will be granted.** This is a rain or shine festival. By submitting your payment you agree to all the terms set forth with in this form. **No electricity** will be available. All Vendors must provide their own tables, chairs and tents. **A deposit check is required for clean- up fee. Please send a separate check for \$50.00.** Check will not be cashed until after event if your space is not cleaned. If space is left cleaned your check will be given back to you.

VENDOR RESPONSIBILITIES: Each vendor is required to obtain the necessary permits through the City of Hammond and the Lake County Health Department. Signage and menu should be visible for patrons for the duration of the event. All vendors must participate 2 days and must remain for the entire time the festival is open. Vendor is Required to clean booth area during and after event. Deposit of \$50.00 will be kept if not cleaned.

EVENT SET UP INSTRUCTIONS: The festival will begin at 4pm on June 7, 2019 you may start set up at 2:00pm. Vendors should be ready for health department inspections by 3:00PM and ready to serve by 4pm. June 8, 2019 Vendors may set up at 9:30AM and be ready for inspections 11:00am and ready serve by 12:00PM
