# Legislative District 23 Republican Committee Monthly Meeting Scottsdale Via Linda Senior Center September 8, 2016 7:00 pm

With concurrence of the members present, the District Meeting of the members of Arizona Republican Legislative District 23 was called to order at 7:00 PM

The Invocation was given by Tim Horn.

The Pledge of Allegiance was given by Gayla Coletto.

In opening, District Chairman Jim O'Connor welcomed everyone and thanked them for their attendance.

Second Vice Chairman, Rich Rutkowski told us that our next meeting will be on October 13th and will be held at the Via Linda Senior Center in Scottsdale. Maricopa County Attorney Bill Montgomery will be the speaker at that meeting. He will be speaking against Prop 205, the recreational marijuana proposition.

The speakers for this meeting were announced: Chris Herring, Chairman of LD21 Republican Committee, and President of Young Republican Professionals; Mark Lewis (incumbent), Jennifer Brown, & Michael Francis, candidates for CAP Water Board.

Chris Herring explained the difference between his group and the other young Republican groups. Its members are from 18 years of age (eligible to vote) to 40 years old. This contrasts with the younger membership of Teenage Republican Clubs. However, they do work together with them. There are also college Republican clubs, but they only exist on college campuses. He reminded us that Michele Reagan and other elected officials, were members of a Young Republican Group. He explained the 5-year plan to grow their organization and asked for a \$10.00 contribution for a bumper sticker as part of their plan to raise money to grow and add new chapters. He also announced his candidacy for Maricopa County Republican Party Chairman.

Suzanne Klapp spoke about her campaign for reelection to the Scottsdale City Council.

Dave Giles, the Republican Nominee for the 9<sup>th</sup> Congressional District, followed and extended his appreciation for the support of his campaign in the primary. He is running against Kyrsten Sinema, the Democratic incumbent and asked for our help in that fight.

Jennifer Brown spoke about her reasons for running for the Central Arizona Project Central Arizona

Water Conservation District 4. She decribed the problems we are facing if the water board isn't brought under conservative control. This is an unpaid, non-partisan position. Ten candidates are running; 5 are Democrats and environmentalist attorneys. She is running along with Mark Lewis and Michael Francis and asked for our support in the general election. A brief Q & A followed her remarks.

Mark Stuart invited us to attend a hearing at 1:30 PM on October 17 at the Palomar Hotel at Jefferson and Central in Phoenix. This hearing relates to alleged problems with the management of the Tournament Players Club golf facility in Scottsdale. Mark explained that this facility is owned by the City of Scottsdale but managed under contract by a private entity. He explained further that there are concerns with a serious lack of transparency on the part of the City of Scottsdale and the projection of an approximately \$50 million financial loss to taxpayers of Scottsdale despite the large revenues generated by the facility, which hosts a popular PGA event each year. Mark stated that, if we wish to preserve our right of self-governance, we must appear at this hearing on October 17.

Nancy Ordowski, First Vice Chair, then highlighted a campaign flyer for many State and Maricopa County candidates in the general election, produced by the team of Mark Lewis, Jennifer Brown and Michael Francis. LD23 will not be producing a "Golden Ticket" for the general election, but campaign materials for candidates and issues to use while walking precincts will be available for PCs. Nancy then told us about Precinct Captain elections. Forms for this purpose are available on the LD23 website. Completed forms should be returned to Nancy. Also, any PC wanting to be elected as State Committeeman must fill out an "Intent to Run" (also available on the LD23 website) and must return the form back to Nominating Committee Chairman Michael Loverine before the deadline of 5:00 PM on October 31. Nancy then explained that early ballots cannot legally be forwarded. She outlined the procedure for use of temporary change of address forms for those voters who will be out of town between October 12 and November 8, 2016, but still want to vote by early ballot. Nancy alerted PCs of the need for polling place volunteers, hand ballot counters, poll watchers, and precinct volunteers. She thanked all those who walked their precincts distributing "Golden Tickets" and other candidate material. Boe James added his opinion about the importance of having our people at the polls to be sure everything is being handled correctly. Nancy will be presenting a class on poll watching. She concluded by describing her experiences at a recent Trump Rally in Phoenix.

Tim Horn offered observations about his personal experience "backstage" and as a driver of one of the transport vehicles for part of the Trump team at the recent rally in Phoenix. He said that everyone in the campaign was friendly and polite. He really enjoyed the experience.

Our Organizational Meeting will be held on December 1. We will be electing new LD officers and State Committeemen. In preparation for that meeting, we must form a Nominating Committee. The duties of the Nominating Committee, as described in LD23 bylaws, were announced. Chairman Jim O'Connor appointed Michael Loverine as the Chairman of the Nominating Committee. Nominations for 4 additional members were requested from the floor. Gayla Coletto, Larry Hagan, Jeannie McGill and Alex Meluskey volunteered to serve. No additional nominations were made and these PCs were accepted by the membership.

Gayla Coletto spoke about her work with the "Constitution in the Classroom" program. She encouraged all of us to get involved.

Liz Alcorn offered information about the MCRC Lincoln Day Awards Dinner, to be held at the Sheraton Grand Hotel in downtown Phoenix on Saturday, October 15, 2016. The cost for PC's is \$60.00 per person. Standard tables of 10 will be sold for \$600.00 for PC. The price for a seat at the speaker's table is \$3000. The awards to be given at the event include a Lincoln bust, a Reagan bust, and others. This annual event honors the commitment and work of PC's who are a credit to MCRC and the Republican Party. More details will be forthcoming.

Michael Loverine proposed a resolution rebuking Senator Jeff Flake for his "Never Trump" stand. Since the language of the resolution was not provided to PCs at least 10 days in advance of this meeting, in accordance with our bylaws, no formal action could be taken. Michael requested that LD23 PCs contact Senator Flake's office and inform him that they will not support his reelection to the US Senate.

Boe James announced the Fountain Hills Republican Club Annual Picnic, to be held at the Fountain Hills Community Center on Saturday, September 17.

Jim O'Connor officially announced his candidacy for Arizona Republican Party Chairman in the January, 2017 election.

Due to time constraints, Valerie Giramberk did not present the Treasurer's report but it will be available for review by PCs in the published newsletter. Also, because of time constraints and the need to vacate the room before closing time, the amended minutes of the August 11, 2016 meeting were not brought up for approval. Those minutes will be voted upon at the next meeting on October13, 2016.
