- ✚ Jenn informed the other Board members that she had responded to the email from the State about the 4-corners being unsafe. Jenn has specifically asked for signs that light up for the town stop signs at the 4-corners.

- ✦ Marjorie Kramer, spokesperson for NEKCUD for Lowell, joined the meeting to talk to the Board about allocating some ARPA funds for the fiber optic internet to be brought to Lowell. The Board asked her to get more detail and some maps showing where this would be most beneficial in town. Once they have this information it will make it easier to know if this would even be beneficial for our town to put ARPA money towards. Marjorie agreed to do so.
- ✦ Christy shared a letter from the Pope Memorial Animal society asking for about \$7000.00 of ARPA money from each town. After careful consideration the Board voted no to this request.
- ✦ Sam came to update the Board on the finishing up of the Town Plan. Marjorie also confirmed that she had stepped down as a Zoning Board member now that the Town plan is complete.
- ✦ The Town Mileage Certificate was reviewed and signed by the Board and the Town Clerk.
