RULES AND REGULATIONS

2019 NORTH CENTRAL ARKANSAS YOUTH BEAUTY PAGEANTS

ALL CONTESTANTS MUST BE A RESIDENT OF ONE OF THE NORTH CENTRAL ARKANSAS DISTRICT FAIR COUNTIES (CLEBURNE, FULTON, INDEPENDENCE, IZARD, SHARP, STONE AND VAN BUREN COUNTIES). A CONTESTANT MUST HAVE BEEN BORN A FEMALE FOR FEMALE PAGEANTS AND MALE FOR MALE PAGEANTS AND A LEGAL RESIDENT OF ARKANSAS. CONTESTANTS CANNOT BE OR AT ANY TIME HAVE BEEN MARRIED, PREGNANT, NOR HAVE HAD A CHILD. CONTESTANT MUST NOT HAVE COMMITTED A CRIME OR HAVE CRIMINAL CHARGES PENDING.

EACH CONTESTANT MAY HAVE A SPONSOR TO PAY THEIR ENTRY FEE, BUT A SPONSOR IS NOT REQUIRED. CONTESTANTS MUST OBTAIN THEIR OWN SPONSOR. ENTRY FEES ARE DUE WITH THE ENTRY FORMS AND MUST BE **RECEIVED** BY SEPTEMBER 20, 2019. CHECKS SHOULD BE PAYABLE TO NCA DISTRICT FAIR.

CONTESTANT AND ONE PARENT OR GUARDIAN ONLY WILL BE ADMITTED FREE AT THE DOOR ON THE NIGHT OF CONTEST.

CONTESTANTS MAY NOT ENTER AN AGE DIVISION THEY HAVE PREVIOUSLY WON IN THE NORTH CENTRAL ARKANSAS DISTRICT FAIR BEAUTY PAGEANTS.

PAST DISTRICT OR ARKANSAS STATE QUEENS ARE NOT ELIGIBLE TO COMPETE AGAIN.
