#### Town funding and grants 2016/2017 fiscal year

#### **Benthicbarriers**

Martha Cohen spoke about the use of benthic barriers on her property and gave a brief description of the blankets:

- Aka Lake Bottom blankets
- Geo-textile fabric re-enforced by rebar to weight down
- 10'-8" X 25'-0"
- Kept in place for about 6 weeks then moved to new location
- Smothers all plant growth underneath the blanket
- Installed perpendicular to the shore either by boat or by walking them out (about 50 60 pounds)
- · Proven to be very effective in other New England lakes

Martha also told the committee that blankets have been built by the committee members for sale to any lake property owner, the cost is \$200.00 each.

#### **ECO Harvester**

Jeff King gave Information about the eco-harvester:

- Manufactured in Wisconsin <u>www.ecoharvester.net</u>
- Harvests up to 1 ½ acres per hour
- Pulls aguatic weeds from the roots using drum / conveyer
- Skims floating weeds, fragments, algae blooms
- Can operate in less than 1 foot of water (10 inch draft)
- Pull weeds next to docks, shorelines
- One person operation
- Harvesting speeds between 3-5 mph
- Up to 10 mph top end speed for transporting weeds
- 3,500 pounds net weight / 8' 6" wide x 19' long
- Drum / conveyer configuration allows weeds to be offloaded
- Automatically pontoon with dual paddle wheel propulsion
  - Cost \$65,000 plus \$6,000 custom trailer (1/3<sup>rd</sup> price of cutter harvesters)
  - Testimonial: Warnes lake management –Canada
    - Had unit for 3 years 900 hours
    - First harvester he's seen that pulls weeds
    - Very reliable: just change fluids regularly
    - Only repair was to drum his fault (tree stump)
    - Reverse conveyor can offload 6 -8 feet from boat
    - Ideal offload is to truck or ramp but he often offloads to dock or lawn to save time
    - He's replaced cutter harvester with eco harvester (much faster and one man operation)
