REPORT ON KEN'S LAKE: The majority of check #8625 to Dave Cozzens Construction was for the recent repair to the lake. However, some of the repair work will have to be redone based on the storm last Wednesday washing gravel away and leaving silt that will need to be excavated out again. Repairs on the inlet will be done a little each year since we do not have enough money to complete this year. Until the lake is drained and dried so equipment can be brought out to the hole, the final repair work required cannot be determined. No water has been going into the lake for three (3) weeks and the irrigation system will be shut down on October 31st. The actual spot where the leak occurred has not been found so we may have to put back in the clay for the first part of the hole then bring the blanket up on top of the clay and compact. Gary suggested solid clay from the pit to do the repair as another option.
