Rental Agreement

ACKNOWLEDGMENT OF RISK, ASSUMPTION OF RISK AND RESPONSIBILITY, AND RELEASE OF LIABILITY

WARNING: There are significant elements of risk in any adventure, sport or activity.

EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY: My/our participation in this activity is purely voluntary. No one is forcing me/us to participate. I/We elect to participate in spite of the risks. I am/We are capable of participating in the activity and using the equipment. Therefore, I agree to assume full responsibility for myself, including any minor children for which I am responsible, for bodily injury, accidents, illness, death, loss of personal property, and any related expenses. I/We agree to wear a U.S. Coast Guard approved personal flotation device (life jacket) while in or upon any water craft. I/We acknowledge and understand that Pennsylvania State Law requires all children 12 years of age and under to wear a PFD (Life Jacket) at all times while in or upon a water craft. I/We agree as follows: To stay AT LEAST 50 feet away from shore while on water craft, to avoid and stay clear from people fishing and casting lines, never land on shore with boats, and to use the beach launch point only when getting in and out of boats upon leaving and returning.

I assume the risk(s) of personal injury, accidents and/or illness, including, but not limited to, sprains, torn muscles and/or ligaments, fractured or broken bones, eye damage, cuts, wounds, scrapes, abrasions and/or contusions; dehydration, drowning, oxygen shortage (anoxia) and/or exposure, head, neck and/or spinal injuries, bite or attack by animal, insect or marine life; allergic reaction, shock, paralysis or death.

I, for myself, and any minor children for which I am parent, legal guardian or otherwise responsible, release the Yellow Bike Rental Company, its agents and employees, from any liability for damage or injury to myself or any person or property resulting from negligence, adjustment, selection and use of this equipment. I, understanding the inherent risk involved in using this equipment, accept the full responsibility for any and all such damage or injury which may result.

RELEASE: In consideration of services or property provided, I, for myself and any minor children for which I am parent, legal guardian or otherwise responsible, any heirs, personal representatives or assigns, do hereby release:
