Old Business:

- Duke has installed the new street lights and poles. One light was moved to be closer to the street. All other lights were placed in the same location as original.
- > Covenants and Bylaws are being made ready to give to the attorney for review. Once they are returned to the board we will make any suggested changes. This copy will then be distributed to the homeowners for their review and questions.
- We anticipate holding a meeting to go over the changes.
- > Once the covenants are in a finalized state, they will need to be ratified. This approved versions will them be distributed to all homeowners and placed on the website.
- > Street and stop signs were replaced by the county. The original wooden signposts were old and in some cases rotting. The county supplies the metal sign posts and signs so we opted for those. The wooden posts will be removed and the holes filled with dirt sometime this spring.

New Business:

- Solicitation if you see solicitors, please let the board know via the website or call or email Light Property Management.
- In an effort to slow down traffic, we ask everyone to mention to their friends and family to slow down and watch for pedestrians as they drive through the neighborhood. We will contact the county to find out if we can put up additional speed limit signs.
- No outdoor burning of yard waste is allowed.

- Last year there was a question of whether cameras can be installed. Due to the work on the covenants the board did not address that question in 2015. We will add it to the 2016 agenda.
- Hunters are again an issue. We will find a contact from DNR and place that info on the website. It was mentioned that at times someone from DNR is at Brown's Bait and Tackle off Berry Shoals Rd.

- **A**. The covenants have the specifics, then submit an architectural review form (be found on the website). Construction can begin once the request has been approved.

- **A.** SJWD had told another homeowner that the only requirement was to use a registered tree service. They will check the tree for any nests and place them on the ground before removing tree.
