# **Treasurer's Report**

Total expenditures to date of \$27850.67 with \$14885.18 currently in bank.

Dues: Carolyn Farrell checks continue to clear. Need to step up amount? *Rob M to follow up with Carolyn and the Charlene.* 

Remaining three homes are delinquent with two almost 2 years behind. Charlene has calculated interest and attorneys fees. Will contact the lawyer to see what is next step as well as typical timing typical of these issues. *No report \_E-mail from Charlene reports 3 certified mailings came back undeliverable. We have done all we can do-next step foreclose on lien?* 

Roof Lien: Charlene to draft letter to homeowner of non-compliant roof as "last chance" before HLHOA forecloses on lien. *September: Letters sent certified. No one party responded to board or showed at October meeting.* 

### Budget 2012:

Board voted to raise dues for 2012 to \$350/yr. Notice to be sent out this month of increase to all HO. *No action yet?* Next year projects: *Need to rework play-set 102nd- Charlene pricing Replace grate covering swale Remove hazard trees in common areas Re-landscape between lakes New lake signage Lake renovation* Swale cover \$2000 New sprinkler heads for play-park \$500 (Rob M has reached out to Silver Lake water district for rebates) New timer and valves for play-park sprinkler system \$500

### **Nominations:**

### Landscape:

More discussion of North lake and weed problem. Looks more like this will be a major project to clean. Board agreed that more has to be done to preserve lakes. Line item to be added for Lake preservation in 2012 budget. Wait to gravel trails after lake work is done. *See Project updates for more.* 

Dead cherry trees need to be replaced around North lake. Earthworks has provided bid to remove and replace for \$225 each. Questions on timing and size of tree remain. Removed one during work party. Will look at again in spring work party.

Pump still on feeding north lake. Dave F. will turn off. Rob gave the combination to the lock.

Rob M will replace the hasp on the shed next available weekend.

Water bill for 32 play-park excessive? Not surprising considering the problems we have had with battery controllers. Recommend budget money to install a real system

Von to 'ping' Earthworks on backflow testing and winterizing of 32 dr playpark. It is in their contract to do both.
