Minutes of December 7, 2020

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Walter Rollin. Also present were Jed Lamb, Robert Holmes, Dennis Finkel, Skip Gentry, Carl Strekely and Sheila Lanning.

Motion by Lamb with a second by Holmes to approve the minutes of the December 7, 2020 regular scheduled meetings as written. Roll call: three yeas. Checks 9314-9335 and payments totaling \$14,074.58 approved for payment. *Motion* by Holmes with a second by Rollin to approve the November Financial report-showing year to date revenue of \$474,249.26, year to date expenditures of \$453,637.57 and bank balance of \$339,771.17. Roll call: three yeas. *Motion* by Lamb with a second by Rollin to approve the payment listing. Roll call: three yeas. *Motion* by Lamb with a second by Holmes to authorize *Resolution 2020-48* amending 2020 appropriations. Roll call: three yeas.

Chairman Rollin introduced Skip Gentry of the Southern Lorain County Ambulance District. Mr. Gentry: runs are down due to COVID-19, however those people transported with the illness are very sick people. The District is ahead of the curve on COVID-19, discuss the illness every day with Doctor. Sterilization, sanitation and disinfectant utilized early. Training continuing on Zoom for a real benefit to residents. Response time is really paying off for residents. Got a new squad and keeping the old one to allow maintenance of vehicles. The district will help the elderly with task like getting mobile, need to encourage people to contact them for help. Vaccines will be discussed at the Board meeting tomorrow, at this time it looks like the elderly in nursing homes and hospital first line staff are first for vaccines with emergency responders third. Discussion on the subject of vaccines and whether to require of emergency responders. Received help from the county with PPE.
