ARE YOU GENERATIONALLY CHALLENGED?

y life is super exciting, so Friday night I was looking through the galleys of the new edition of the Chicago Manual of Style, and I noticed a little change from the previous edition. In the past, Chicago said to lowercase "generation X," even though other style books said to capitalize it. With the new edition in September, Chicago is going to be in line with the Associated Press, making editors' lives easier: capitalize "Generation X." And if you call us "Gen Xers" on second reference, capitalize that too.

But knowing when to capitalize the name of a generation isn't as straightforward as you'd think. Although "Generation X" is capitalized, "baby boomer" and "millennial" are lowercase, but then "the Greatest Generation," which generally means Americans who became adults during World War II, is often capitalized.

So what's going on? Well, my best guess is that "baby boomer" and "millennial" are made-up

that describe the names generations, but "Generation X" and "the Greatest Generation" were both popularized by books that have those titles, so there's some pressure or feeling that they should be capitalized. Oxford English Dictionary does show people occasionally using both of these names before the books came out, but it was really the books that made these names popular.

'Generation X' Was a Book Title

"Generation X" was the title of a novel published by Douglas Coupland in 1991. The publisher's description says the main characters "Andy, Claire, and Dag, each in their twenties, have quit 'pointless jobs done grudgingly to little applause' in their respective hometowns and cut themselves adrift on the California desert. In search of the drastic changes that will lend meaning to their lives, they've mired themselves in the detritus of American cultural memory."

'The Greatest Generation' Was a Book Title

"The Greatest Generation" was the title of Tom Brokaw's best-seller that profiled military heroes, community leaders, and ordinary citizens who served their country during World War II. Before they were called "the Greatest Generation," they were sometimes called the "G.I. Generation" or the "World War II Generation."

Single Letters Are Usually Capitalized

Further, because we usually capitalize a lone letter, like X in "X-ray" and T in "T-shirt," the capitalized X in "Generation X" put further pressure on capitalizing the word "generation."

So, for these reasons, there's some inconsistency in whether you capitalize generation names. Keep "baby boomer" and "millennial" lowercase. You'll see more variety in how publications treat "the Greatest Generation" and "Generation X," but they're often capitalized.

'Generation Z' Needs a Better Name

Oh, and so far, the generation after the millennials seems to be going by "Generation Z." Follow the style of "Generation X" and capitalize "Generation Z" too. The reason I say "so far" is that millennials were originally called "Generation Y," but then they got a better name, so I'll keep my fingers crossed for Generation Z's prospects.

What Years Were These Generations Born?

Another tricky point is how to actually define these generations because, aside from the baby boomers (who get all the good stuff), people don't agree on the definitions.

Everyone seems to agree that baby boomers are the people who were born after World War II, between 1946 and 1964. The AP Stylebook says that span is defined by the Census Bureau. Boomers have also been called the "me generation."

But then Generation X is defined simply as the generation after the baby boomers, and millennials are defined as two generations after the baby boomers.

If the baby boomer generation ends in 1964, then Generation X must start with people born in 1965. When it ends is the fuzzy part, but most sources say the last Gen Xers were born in 1980, plus or minus a couple of years. Generation X was also sometimes called "the MTV generation."

Given the uncertain end-date of Generation X, the millennial

generation is even less well-defined. Their start date is whenever you agree that Gen X ended and there's an even broader range of when people say the last millennials were born—anywhere from the mid-1990s to the early 2000s.

I'm not even going to try with Generation Z. Ethnographic studies from the Census Bureau say that we'll only know the best boundaries for younger generations after more time passes.

So generations are trickier than you might have thought. The cutoff dates are fuzzy and you capitalize some (the Greatest Generation, Generation X, and Generation Z) and you keep others lowercase (baby boomers and millennials).



- The 8th District Court will continue to conduct Examination Conferences in the morning and Examinations in the afternoon on Tuesdays, Wednesdays and Thursdays.
 - The District Court will amend their scheduling practice to specifically align Examination Conferences and Examination courtrooms.
 - The District Court will employ a random assignment system for each case at the District Court Arraignment to ensure random assignment to Examination Courts and the corresponding Trial Courts.
 - o Circuit Court Pretrial Conferences will be scheduled on the 3rd Monday from the Examination Date.
- Each Circuit Judge shall be responsible for his/her assigned criminal cases from bindover to post-judgment matters.
 - Requested warrants and Show Causes will be signed by the assigned Judge.
 - o Each courtroom will be responsible for scheduling bond violation hearings at their convenience.
 - Courtroom B will be responsible for Men's Drug Treatment Court, Women's Drug Treatment Court and Swift & Sure Sanctions Program matters (Probation Violation Arraignments, Probation Violation Hearings and Due Process Hearings), Juror Show Cause and Arraignments, except those Probation Violation Sentencings when the case would ordinarily return to the sentencing judge.
 - o If an assigned judge is not available, a judge will be designated to cover for scheduled and unscheduled absences.
- Personal Protection Orders (PPO)
 - The Circuit Court PPO Coordinator moves to Crosstown Parkway Courthouse on September 1, 2017.
 - Beginning August 1, 2017, all ex-parte PPO requests are reviewed and considered at Crosstown by the Civil Division Judge and may be reviewed and

- considered at the Gull Road Courthouse by a Family Division Judge if there is an existing Family Division file with activity in the last six months.
- Beginning August 1, 2017, ex-parte petitions and proposed orders will be processed electronically.
- Beginning August 1, 2017, all PPO Hearings (non-PPO Violations) will be held at Crosstown with Civil Division Judge or at the Gull Road Courthouse by a Family Division Judge if there is an existing Family Division file with activity in the last six months
- PPO Violation Arraignments (Show Causes) and Violation Hearings will be heard by the Criminal Division Judges.
 - PPO Violation Arraignments:
 - Even number cases by Courtroom A
 - Odd number cases by Courtroom C
- Courtrooms A and C will be responsible for scheduling PPO Violation Hearings at their convenience.
- o If an assigned judge is not available, a judge will be designated to cover for scheduled and unscheduled absences.

Duty Week is Eliminated

- Each Circuit Judge is responsible for his/her own Bench Warrant Arraignments, including Office of Community Corrections, Failure to Appear, Complaint of Violation on Conditions Release, Probation Violation Arraignments. These arraignments will be scheduled for 1:30pm each day of the week.
 - The three judges will share one Michigan Department of Corrections officer and the judge(s) that are not currently in trial will be the most flexible in terms of when his/her arraignment(s) occur(s).
 - If an assigned judge is not available, a judge will be designated to cover for scheduled and unscheduled absences.
- o Probation Violation Hearings include Informal and Formal Hearings.
 - Michigan Department of Corrections will continue to provide one agent on Tuesday, Thursday, and Friday mornings for Informal Hearings.
 - The Circuit Court will assign Susan Prentice-Sao to represent indigent defendants on probation violation matters.
 - Ms. Prentice-Sao will be responsible for finding appropriate attorney coverage in her absence or should a conflict arise.
- With the exception of the schedule pursuant to the table on the first page, each courtroom enjoys some flexibility to their schedule so long as it does not negatively impact the Kalamazoo County Sheriff's Office or the Michigan Department of Corrections.
 - Should the Office of the Prosecuting Attorney continue to assign multiple assistant prosecuting attorneys to a courtroom, a Circuit Judge may choose to adopt a scheduling practice that allows for a vertical prosecutor on certain week(s).

- Generally speaking, Courtroom A and Courtroom C Settlement Conferences will be 8-days prior to the trial date. Generally speaking, Courtroom B Settlement Conferences will be 11-days prior to the trial date.
- Each courtroom will be responsible for scheduling motions and evidentiary hearings at their convenience.

• Civil Settlement Conferences

- Courtroom A will hear Settlement Conferences for civil non-jury trials on Mondays at 11:00AM and at 3:00PM.
- Courtroom B will hear Settlement Conferences for civil non-jury trials on Mondays at 11:00AM.
- Courtroom C will hear Settlement Conferences for civil non-jury trials on Tuesdays at 3:00PM and Fridays at 3:00PM.

• Motions to Set Aside Convictions

 Motions to Set Aside Convictions shall be scheduled for Mondays when a courtroom is scheduled to conduct sentences.

Problem-Solving Courts

- Judge Lightvoet will continue to conduct Veteran's Treatment Court every other
 Friday afternoon in Courtroom C.
- Judge Bridenstine will continue to conduct Men's Drug Treatment Court every other Friday morning in Courtroom D.
- Judge Bridenstine will continue to conduct Swift and Sure Sanctions Program admissions every other Friday morning in Courtroom B.

• Financial Show Cause

- Financial Show Causes will continue to be held on Thursday mornings at the Michigan Avenue Courthouse.
- o If multiple cases comprise a Financial Show Cause, the judge assigned to the oldest case will be responsible for the matter.
