Ordinance No. O-2016-37

**AN ORDINANCE REPEALING ORDINANCE NO. O-2016-33 REGARDING THE
ANNEXATION OF 0.193 ACRES AND DECLARING AN EMERGENCY.**

WHEREAS, Alma Jean Miller and Terry Dyer, the owners of certain territory comprising 0.1963 acres contiguous to Amelia Village, made application to the Clermont County Board of Commissioners to annex said territory to the Village of Amelia; and

WHEREAS, the Clermont County Board of County Commissioners approved the annexation by Resolution No. 108-16 adopted on June 22, 2016; and

WHEREAS, the Council of Amelia Village adopted Ordinance No. 2016-33 accepting the annexation prematurely; now therefore,

BE IT ORDAINED by the Council of the Village of Amelia Clermont County, Ohio a majority of its members concurring.

SECTION I. Ordinance No. 2016-33 is hereby repealed in its entirety.

SECTION II. This ordinance is hereby declared an emergency which is necessary for the preservation of the public health, safety, and general welfare. The reason for such necessity is the immediate need to pass a new Resolution accepting the annexed property at the earliest possible time in compliance with state statutes. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

SECTION III. Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code.

D. CAMPBELL moved to suspend the rules requiring three readings on three separate dates.




