NATIONAL EXAMINING BOARD OF OCULARISTS

The National Examining Board of Ocularists was formed in November 1980, in response to the need for more uniform standards in the field of ophthalmic prosthetics.

The National Examining Board of Ocularists is an independent agency whose primary function is the assessment of competence of the ocularist who performs the variety of health care related functions encountered in the fitting and fabrication of ophthalmic prosthetics.

The Board consists of eight members, appointed by the American Academy of Ophthalmology, the American Board of Certification of Orthotics and Prosthetics, the American Society of Ocularists, The Canadian Society of Ocularists and a Public Member elected by the National Examining Board of Ocularists.

The Certification Examination is offered annually and is a two-part examination consisting of written and practical sections. The examination is a criterion-referenced examination that has been developed and continues to be re-evaluated utilizing techniques that are accepted and approved by the psychometric community.

The National Examining Board of Ocularists is a member of The Institute for Credentialing Excellence (ICE), formerly the National Organization for Competency Assurance (NOCA). NEBO, with CASTLE World Wide Services, will continue to meet the most rigid standards of excellence in test development and administration in certification.

The National Registry

The National Registry for Certified Ocularists is an alphabetical and geographical listing of all currently Board Certified Ocularists in the United States, Argentina, Belgium, Canada, India and Venezuela. This list includes individuals who have qualified to sit for the examination by having completed the necessary education and/or training and experience requirements and having completed these preliminary requirements, have further demonstrated (voluntarily) a competence in the fitting and fabrication of ophthalmic prosthetics by satisfactory completion of the National Examining Board of Ocularists certification and recertification requirements.

Once Board Certification has been achieved, the National Examining Board requires a specific number of continuing education credits in the eye health care related field and ocularistry. These CE credits are compulsory for both updating the registration of the certificate three years post examination, and toward recertification examination every 6 years. Although certification was a voluntary action taken by the entrants of this registry, this added measure of continuing education credits assures their intent to abide by the standards set by the NEBO and NOCA.

It is the intent to provide a national standard that can be used as a measure of professionalism by interested agencies, groups, and individuals. The responsibility for professional integrity and excellence remains with the ocularist.

The contents of this registry cannot be duplicated or altered in any way.
