During the first 48 hours after opening, the initial limit of entries designated as either online entries or paper entries will be as follows: Online Entries: 33% (220 runs) Paper entries: 67% (440 runs). If either form of entry has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either the online or paper limits accordingly.

#### Paper entries received within 24 hours of the opening date & time limit must:

#### Walk-through & Warm-up

At the discretion of the judge, if the size of the entry for any class might inhibit a safe and fair walk-through by handlers, height divisions may be used to divide the walk-through into groups, e.g. walk-through for the 8", 12" and 16" division handlers followed by runs for those height divisions; then walk-through and subsequent runs for the 20", 24" and 26" divisions. A warm-up area, consisting of a regulation agility jump, will be provided. Umbrellas are not allowed on the course during the walk through.

#### **CLASSES OFFERED & JUDGING TIMES**

#### Classes Offered

All levels of Standard STD, JWW, FAST and T2B, including the preferred classes, will be offered according to the entry form. (International Sweepstakes Classes will be offered when indicated in the premium and on the entry form). #### **ELIGIBILITY AND HEIGHT DIVISIONS**

#### **Dogs Eligible to Enter**

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or are register-able breeds that have obtained PAL/ILP numbers from the American Kennel Club, except bitches in season, aggressive dogs, blind dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. **Mixed breed dogs** listed in the AKC Canine Partners program are eligible to enter this all-breed AKC agility trial. Mixed breed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. Box.

#### **Jump Height Information**

All dogs without height cards will have to be measured by the judge of record, except 24"/26" dogs. If a VMO or an AKC Representative is available, all dogs without height cards, including 24"/26" dogs, will need to be measured. When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. #### **EXHIBITOR INFORMATION**

#### Important Information for Exhibitors

- All owners and handlers are responsible for correctly entering and participating in this trial in accordance with AKC rules. Owners are responsible for errors in entry forms, regardless of who may make such errors.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. AKC does not permit pinch/prong collars, electrical or special training collars anywhere on the trial grounds.
- The safety of dogs is of primary concern. By entering the trial, exhibitors acknowledge that they are familiar with the rules and regulations of the AKC agility program, and that their dogs are familiar with and able to perform all obstacles safely.
- Confirmation of entry and a schedule of judging time will be sent to the address (email will be used when provided on the entry form) on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, the trial secretary should be contacted. Returned checks do not constitute a valid entry. If a check is returned, the entry will be deemed invalid, and the issuer will be billed for all trial associated fees, including, but not limited to: AKC fees, judges fees and secretarial fees. 
