In October of 1989 my oldest son, Sean Cater, was murdered at age 21. As a result of this tragedy I founded Giving God the Glory Ministries in 1997. Under this not-for-profit Ministry, I facilitate and organize bereavement programs and support groups as well as mentoring programs for teens and women. My youngest son, John Cater Jr., an Award Winning Journalist, died in January of 2010 at age 32. This was 6 months after he won the prestigious Emmy Award for Excellence in Reporting.

I am so proud of honoring the memory of my two sons, John Lewis Cater Jr. and Sean Anthony Cater, through the Giving God the Glory Ministries Scholarship Program.
