B. Update on improvement projects for 2020

D. Volunteer Landscape Advisory Committee

Arthur Schuetz advised the committee is meeting monthly to review service request and established a plan to address maintenance standards. Arthur requested management to add to the action list the "observation form" draft to be prepared for the committee to review.

E. Irrigation Evaluation

Andrew Chase from Resource Management Consultant was present to discuss his business services to assist the association with landscaping oversight of water conversation with state of the art irrigation control. The association will assign a irrigation meter for Andrew to review and provide a sample of his services.

6. NEW BUSINESS

A. Landscaping Lighting

TBM Electric presented a proposal for \$1,017 for a damaged j-box and damaged wiring near anthem country club sign. Arthur Schuetz made the motion to approve the repair as presented. Larry Orlov seconded the motion. There was no further discussion, motion passed with all favor.

TBM Electric presented a proposal for \$54,876 for 104 flood lights that shine up at nothing with the recent tree removals and around the waterfall. In addition, re-locate 89 lights to areas on the parkway. 15 lights will be stored for future repairs. Larry Orlov made the motion to table this item until further review with TBM electric. Joe Lightowler seconded the motion. There was no further discussion, motion passed with all favor.

B. 2021 Budget Committee

Larry Orlov, Mark West, Joe Lightowler and Arthur Schuetz volunteer to review and prepare the 2021 Anthem Community Council budget to adopt a the August meeting.

C. Insurance Renewal

Management advised the Board of the efforts to obtain comparable bids. The open legal case is preventing a carrier from providing a bid that competitive to the current policy. Alan Dees made the motion to approve the renewal of the current policy with American Family. Arthur Schuetz seconded the motion. There was no further discussion, motion passed with all in favor.
