Motion was made by Trustee Perrin, seconded by Trustee Russell. Acting Mayor Carr asked if there were any questions or corrections? There being none, the following Trustees voted in favor of said motion:

The following Communications presented for this evening:

Acting Mayor Carr wanted to extend a thank you to Crystal Sky Banquets for providing lunch for our employees and a thank you to Fontanini/Hormel for providing food and miscellaneous items to our first responders.

There was no Special or Unfinished Business presented for this evening.

Acting Mayor Carr stated that the following New Business was presented for this evening:

Motion was made by Trustee Mandekich, seconded by Trustee Perrin to approve a request submitted Commissioner Richard Paeth seeking authorization to purchase a 2020 Chevy Silverado 2500 HD pickup truck from Advantage Chevrolet for use by the Department of Public Works. The 2016 Chevy Tahoe will be traded in with a value of 34,500.00. The total out-of-pocket cost will not exceed \$10,000.00. Acting Mayor Carr asked if there was any discussion. There being none, on roll call the following Trustees voted in favor of said motion:

Acting Mayor Carr asked Mike Thiessen to address the board regarding the hotel project on 47th Street. Mike Thiessen met on May 1 with the developer regarding any updates. Mike Thiessen shared details with the Board regarding different issues they are having. Mayor Carr is giving them a June 15th deadline to comply with the RDA. The Mayor stated that an option for the village could be to take back the property and redevelop.

Page 7 June 1, 2020

Acting Mayor Carr asked Attorney Gary Perlman to address the board regarding the Ortek property. Acting Mayor Carr stated that they are allowing \$100,000.00 and that they have used \$12,000.00. The EPA has cleaned up tank 101 and marked it as clean. The Board has to decide what they want to do with the property if the remaining \$88,000.00 is used without the clean-up project being completed. Attorney Perlman advised that the Village could be liable for this site. An option is to have someone purchase the property, begin paying taxes and take on the responsibility of the clean-up. This is why an Environmental Attorney was hired and cost the Village a substantial sum. He stated that if another firm is hired, the fees would have to be paid again. He discussed the 2-year-old case that the village won on 04/29 and stated that an appeal was filed by Ortek on 05/29. It will most likely take another 2 years to resolve this appeal.

Attorney Perlman stated that the following Ordinances and Resolutions were presented for this evening:

Motion was made by Trustee Cernetig, seconded by Trustee Russell to pass and accept **Ordinance No. 20-13** entitled, "An Ordinance Amending Chapter 2, Administration, Section 2-36, Meetings; Order of Business, of the Code of Ordinances, Village of McCook, Illinois." Acting Mayor Carr asked if there was any discussion. Attorney Perlman states that the meetings will begin at 6:00 instead of 7:00. The Ordinance also clarifies the order of the Agenda items. There being none, on roll call the following Trustees voted in favor of said motion:

Acting Mayor Carr declared a State of Emergency yesterday to expire at the end of the Board Meeting, due to the rioting in surrounding areas. Governor Pritzker implemented a 30-day proclamation and the Mayor can re-issue if necessary. Acting Mayor Carr stated that last night all off ramps were closed down to prevent people coming in from the city. They further discuss issues regarding the rioting. Acting Mayor Carr wants all residents and businesses to remain safe.

Acting Mayor Carr would like Police Chief Depasquale to look into getting a canine dog.

Acting Mayor Carr advised that the City of Chicago will be raising the water rates.

Saban's Restaurant is interested in the Alta Grill site as soon as COVID is over. We will not put any additional money into it. The village will keep the concession stand and the charitable poker.

Fire Chief Myrick spoke about COVID-19 and village business.

Commissioner Paeth is winding down on his projects in the Water Department and Superintendent Perrin provides updates on his department.

MAX Director Jered Wieland stated that the MAX opened with restrictions and gives updates on projects they accomplished during the shutdown.

Mayor Carr thanked the DPW and Fire Department for the setup for the Board Meeting.

There being no further business, a motion was made by Trustee Perrin, seconded by Trustee Cernetig to adjourn this meeting. On roll call the following Trustees voted in favor of said motion:
