CORRESPONDENCE FROM THE FISCAL OFFICER:

Minutes from the August Meeting being read prior by the Board were approved as read, so moved by Trustee Hurley and seconded by Trustee Wolfe. All were in favor with 3 ayes and no negative votes, motion passed. The fiscal officer had nothing new for the board.

FIRE DEPARTMENT:

Fire Chief Golden reported monthly runs so far have been 11 fire and 50 EMS for a total of 674 runs YTD. Mutual aid was provided to Amanda, Berne, Pleasant, and Lancaster. We have received another grant for \$3,398 for the purchase of two AED's from the Aladin Shriner's. We also received a grant from them for the acquisition of an additional thermal imaging camera. We have two volunteer applications that are in the process of background checks. We had one resignation from the department.

OLD BUSINESS

- 1. The only house left for demolition is on Hamburg Road and is being scheduled by the county land bank.
- 2. Scott Brown's property was declared, by resolution a nuisance property at the June 2023 meeting. Mr. Hogle posted the violation on the property and date stamped with a picture. The trustees and zoning inspector will be sending a certified letter to Mr. Brown advising he has 10 days to clean up the property or the trustees will contract the work out.
- 3. Trustee Wolfe and Zoning Inspector Hogle visited the property and identified what items need cleaned and removed from the property. The township will place the cost against their property taxes.
- 4. Trustee Wolfe motioned to amend resolution 23-09 and to add into Resolution 23-13 per ORC 505.87, the Board of Trustees have declared Scott Brown's property a nuisance. Steps will be followed per the Fairfield County Prosecutors Office to have the property cleaned up. Trustee Hurley seconded the motion. Roll call vote Ellinger Yes, Hurley yes, Wolfe -Yes. Motion approved.
