**Salute to the Flag / Regular meeting call to order:**

Chairman- Jaime Hartline, Vice-Chairman- Raymond Guzic Jr., Supervisor Scott Guzic Solicitor Thomas Swope and Secretary Pamela Flis.

David Myers, Reverend Scott Little, Tony Zummer, Scott Steberger and Joshua Beyers representing Mainline Newspapers also attended the meeting.

**Public Participation:**

As Discussed:

Tony Zummer- Informed the Township Supervisors that the settling ponds on Memorial Drive are full of soil from the recent heavy rains.

Reverend Scott Little and David Myers-both have concerns with the amount of ATV traffic on Hilltop Road. The recent ATV accident along Hilltop Road and the disregard of common sense when operating an ATV. A section of Mountain Road in Washington Township is designated to all forms of vehicular traffic, the roadway is clearly marked. PA Law- ATV's not permitted on Township roads without the proper permitting. The PA State Police should be contacted by township residents with regards to offending ATV traffic. The only way to prosecute offenders is to video tape the ATV and be prepared to testify in a court of law. The law enforcement officers will not chase an ATV nor arrest juveniles. Hilltop Road is a residential neighborhood. The Washington Township Supervisors will contact the PA State Police and inform the association of the ATV traffic on Hilltop Road.

Scott Steberger- along with Ronald Muldoon are planning to clean up Bear Rock Run from Memorial Drive down to Lilly Borough. Requested the townships help with removal of any large items that may be found in the creek. The Supervisors are in favor of helping with the large item cleanup. A township resident has several large stones that he would like to donate to the the Regional Recreation Center. The letters of support from the general public with regards to the current grant being submitted in 2017. Lilly Sustainability Project-planned gardens, planting native species of trees to benefit wildlife, recycling bins for cans, compost site for use by the general public, wind and solar energy, the Marnier East Pipeline Project and training of emergency services personnel.
