General Information

PURPOSE/BACKGROUND: EAB Construction LLC is soliciting requests for quotes for the purpose of performing and completing waste management. The project is approximately 1255 square feet, located in the Atrium of the North Terminal of the HJ-AIA. All work will require all workers to pass security backgrounds. Work will be performed at the hours of 11pm to 5am only on Sunday through Thursday. A 72 hour notice and approval is required for any other work performed outside of the hourly range. Tool lists are to be submitted for approval for all work located in SIDA (Security Identification Display Areas) of airport. The project site is located in a non-SIDA area but all work that will be performed is considered to be under SIDA restrictions. Only work performed below or above the project site will require tool lists approvals. All work is scheduled for completion by November 20, 2018.

BRIEF SCOPE OF SERVICES: Vendors shall provide a scope of work and project quote in accordance with the information provided in this request. The Quote must include the following elements:

- Detailed work plan that identifies the major areas of work
- An estimated proposed timeline for deliverables
- Brief safety plan for maintaining tools and work area.
- Detailed cost estimates.

QUALIFICATIONS:

This project will require the firm or individual to have the following qualifications:

- 2 to 5 years of related experience
- Valid trade licensing, if applicable

- Security clearance with Hartsfield-Jackson Atlanta International Airport which may include parking, badging, and driving.
