Soon after that Ms. Mary Miller called Jamie and asked what went on at the meeting. He said he explained to her about the meeting also shared he and Josh's conversation. She was coming to the town meeting, but went to the superintendent; the superintendent has always told her that Arnaudville would never close.

This is the only school in the parish that has the highest performing grades and has always been the highest.

A brief discussion was held, different views were had.

Deputy Angelique Stelly is in her sixth week of training at the St. Martin POST Academy. During the next two weeks she will be going through firearm training.

Chief thanked the Council on the approval to hire Ms. Christian Deville to the position of Dispatcher at a starting salary of \$9.02 per hour (Grade 1 Step 33). At the time of her hiring chief thought the starting pay was at the old rate of \$8.56 per hour but after review he realized he made a mistake and contacted Dolores in the front office to make the necessary correction.

At the last Council meeting on January 19, 2021, Chief asked for approval the drug screens and physical of prospective employees be conducted prior to asking for approval to hire. When Ms. Deville was approved for hire, he followed the advice of the Council and instructed her to get the necessary procedures done prior to her actually beginning her training. Due to the weather and holidays Ms. Deville could not actually start training for ten days (the time between her being approved for hire on February 10, 2021 until all the paperwork was received by the office on February 19, 2021 and she was allowed to begin training on February 20, 2021). If the Council wishes to continue the practice of waiting until a person is hired prior to having these procedures done, then he recommends that the newly approve for hire employee be paid 4 hours for having to do so. As he mentioned before, should these procedures be done during the pre-employment phase the candidate could begin training immediately after their approval, unless they had to give their current employer (if they are employed) a notice.

Also, at the last Council meeting during his Police Department Report a request was made to approve his recommendation to reinstate Mr. Barry Ard to the position of Reserve Officer. No vote was taken and he is trying to determine if the Council intends on voting on his recommendation.

He has a few people, mostly veterans; bring to his attention the proper protocol for displaying the American Flag at the new sign that is at the traffic signal between the Teche and Fusilier Bridges. While the flags are placed in the proper order, with the Stars and Stripes situated at the far left as you view the sign head-on, the American Flag should fly higher than other flags that are included is the display. According to protocol and tradition, the other flags are to be flown lower than the American Flag. Since the flag poles are already installed at the same height I wish to recommend to the Council that the other three flags be flown approximately six inches lower than the American Flag out of respect for those who have served or who are now serving. It is also appropriate for a single spotlight to shine independently on the American Flag whenever it is flown after dark. Statistics from the Arnaudville Police Department for the month of January were: 28 Citations, 16 FIC's, 20 MIC's, 3 arrests and 98 calls for service, while 45% of time worked by the Officers was spent on patrol of the town and business checks.
