Roberta read the minutes of the meetings of June MINUTES 21 and 29, 1988. After calling for additions or corrections and hearing none, the Chair declared the minutes approved as read.

Dale reported he has two quotes on repairing REPAIRS - G.W.W. Well #4. Munroe Supply for \$7,363 and one from GEORGE WHITE Rhodes Bros for \$4,837. If it is the Board's pleasure, he WELL #4 will get back to the other suppliers he contacted Friday and get at least one more quote. George moved to have Rhodes go ahead and get the well fixed as fast as possible. Bill McDougald seconded. MOTION CARRIED. Gary has contacted a company from Price, which has a crane for \$75.00 per hour. Dale stated the crane from Grand Junction had cost \$70.00 an hour.

George Carter stated his family was here because WATER TABLE he heard the District was doing some drainage on East Bench ON EAST Road and they would like to be included in any project. Dale read the letter Paul Rattle had brought in on Friday, written to Dee Hansen, regarding the Division's engineering report on the groundwater problem. Gary questioned the map included in the engineering report from Division of Water Resources, and wanted to know who would maintain any ditching and drainage put in. The report was discussed and George White moved the District write the County Commission, ask them to do an accurate survey of all the land involved, and not study this groundwater problem piecemeal. McDougald seconded. MOTION CARRIED.

BENCH ROAD

The proposed rules and regulations, as published, for Ken's Lake were discussed and Dale feels the District can work with San Juan County if any digging has to be done. The various references to "designated camp areas" were discussed and Dale thinks San Juan County might have some plans regarding recreation and camping sites. George asked if we shouldn't contact San Juan County and see if they might take over the trash cleanup.
