Nancy Simmons

Nancy started in pure-bred dogs with Great Danes. Her first Dane earned her Championship and Companion Dog degree. With the success of her puppies in her only litter, she earned the Great Dane Club of America award of Honor Roll as the dam of three champions.

Nancy continued to participate in both conformation and obedience with each generation of Danes. She also owned and showed a Golden Retriever.

In 1995 Nancy got her first Doberman Pinscher puppy, who became CH LeMils Simmons Seville UD ROM. Nancy and Seville competed in the Obedience Top 20 at the 1997 Doberman Pinscher Club of America National Specialty.

In her judging career, Nancy has enjoyed being in both the obedience and conformation rings. In obedience she is approved to judge all obedience and rally classes. In conformation, AKC has approved her to judge the Working Group, the Sporting Group, nine Herding breeds, Best in Show, Junior Showmanship, and Miscellaneous breeds.

Nancy works full time with her husband Carl in their business as a general contractor doing commercial construction. Her daughter Cindy is a physician whose specialty is Emergency Medicine. Cindy has two children. Nancy is proud of her grandson Christopher and granddaughter Julianne. Nancy's son Andy earned his PhD in Biochemistry and works for a pharmaceutical company in the San Francisco area. Andy's son Jason is a good student and participates in many sports. Nancy feels blessed to have three healthy grandchildren.



Patricia Trotter

Patricia Trotter acquired her first Norwegian Elkhound as a young girl, entered her in her first show in 1950, and bred her a year later. Since then, she and her Vin-Melca Norwegian Elkhounds have won 11 Group Firsts at Westminster Kennel Club all owner-handled, a record that stands to this day.

When Pat was 11 years old, she started her own grooming business. "I'd knock on the doors of people with dogs with a carton of grooming supplies. For 50 cents I'd wash, groom, de-flea their dog on site and make it look as beautiful as I could!" She also worked at nearby kennels and veterinarian offices, learning as much as she could about grooming, showing and caring for dogs.

Pat has bred and owner-handled the top sire and dam in Norwegian Elkhound history. Thirty-nine Vin-Melca Elkhounds have accumulated all-breed BIS honors to date, the latest being CH Vin-Melca's the Jaywalker in February, 2022 with Pat handling.

Pat has won numerous Quaker Oats awards, Pro Plan Hall of Fame, 2 Fido awards, and AKC's Lifetime Achievement Award. Her book, *Born to Win* has become a bible for dog breeders, and her AKC Gazette column won a Maxwell award from the Dog Writers' Association of America.

Pat handled her own dogs to Top Ten All Breed status on 10 different occasions while she balanced family, dogs, and a full-time job teaching history at Carmel Middle School.
