Dear Mr. Socks:

Thank you for your letter of June 15th regarding my previously submitted Right to Know Request. Your letter states that I modified my request in conversations with the Township Solicitor to a specific address, 141 Huff Road. Please be advised that I did not amend my original request, which was for information relating to any instances of debt forgiveness related to sewer bills, permits, ordinance violations or similar assessments, for all calendar years from 1999 to the present.

As I review my notes from my conversations with the Township Solicitor, I recall that I mentioned a Board of Supervisors' meeting where sewer bills were discussed, and in particular a residence that had not paid in a long time or perhaps ever. I told the solicitor that Chairman Foltz and Supervisor Danner had a whispered conversation where I heard them say that "the man's wife died." From that, I can only assume that your solicitor extrapolated the address of 141 Huff Road, as I was not personally aware of any addresses that have or had outstanding sewer bills.

Again, I did not modify my initial request in either of my conversations with the solicitor. It appears the solicitor may have misunderstood what I was asking for when I told him about the whispered conversation above and thought I was only interested in the home where the spouse passed away. My original request stands as stated above.

Dear Ms. Adams:

We received your June 24, 2015 letter on June 29, 2015 and have the following response. First, we apologize that was an apparent miscommunication between you and the Township's Solicitor regarding your Right-To-Know Request. It was our understanding that you were specifically interested in the issue regarding the sewer bill relating to a property on Huff Road. We undertook the effort to identify that particular property and responded accordingly.

Nonetheless, regarding your request, after a good faith search, the Township does not have a record setting forth property owners, who owed debts or assessments to the Township that would normally be collected by the Township treasurer, whose debts/assessments were forgiven. Under the Right-To-Know Law, the Township is not required to conduct research to compile a record that does not otherwise exist.

As an alternative, you are certainly welcome to inspect the Township's minutes at the Township office during regular business hours. The Township's minutes for 2010 through 2015 are posted on the Township's website. All minutes from 1999 through 2015 are also available at the Township building for inspection, as aforesaid.
