HEALTH DEPARTMENT

COVID-19 Statistics:

As of January 8, 2021, there have been 4569 confirmed cases of COVID-19 in Lenawee County; 58 new confirmed cases since yesterday. We currently have 1256 active confirmed cases of COVID-19 in Lenawee County; 20 of those cases are hospitalized. There have been 69 confirmed and 3 probable COVID deaths reported to date in Lenawee County.

Vaccination Statistics:

On December 28, 2020, the Lenawee County Health Department (LCHD) began providing COVID-19 vaccinations to individuals who live or work in Lenawee County. As of January 8, 2021, the Health Department has vaccinated 560 individuals. The vaccine will initially be available in limited quantities and will be distributed based on the vaccination prioritization guidance from Michigan Department of Health and Human Services https://www.michigan.gov/documents/coronavirus/MI_COVID-19 Vaccination Prioritization Guidance 710349 7.pdf.

The Lenawee County Health Department continues to administer COVID vaccine to healthcare workers and medical first responders in Phase 1A and will soon be vaccinating those individuals age 65 and older and some frontline workers including police officers, first responders, frontline state and federal workers, jail and prison staff, preK-12 teachers and childcare providers. The Health Department has established partnerships in the community that will be utilized to increase vaccination capacity as vaccine availability increases.
