## REVIEW AND APPROVE ASCERTAINED MERIT FOR LIEUTENANT TESTING

There are nine engineers at Mokena FPD; seven are qualified for the exam; five of which took out applications & one of them did not turn in their packet.

Due to several Office of State Fire Marshall educational certifications being repealed, a revision in the Illinois Office of the State Fire Marshal Administrative Code in November 2017, the Commissioners reviewed each candidate's application, verified each certification that was valid, and added up the total ascertained merit points for each candidate.

Commissioner Chris Surdel made a motion, seconded by Commissioner Barz to approve the ascertained merit for each candidate for Lieutenant Testing. Motion passed with all ayes.

#### **2021 FULL-TIME HIRING PROCESS**

Advertisement for the 2021 Full-Time Hiring Process will begin in late July or early August.

The written test is scheduled to take place at Lincoln-Way East High School on Saturday, October 2, 2021.

The Assignment of Preference Points were reviewed & agreed upon by the Fire Commissioners.

The Commissioners also agreed to have the Oral Interviews take place during the first week of November 2021 either on a Tuesday, Wednesday or Thursday (date to be determined). Each interview will take approximately 10 minutes, as it has done in the past testing.
