I. Call to Order Mike McGrew 1 min

Meeting called to order at 1844 hours.

II. Approval of Minutes Mike McGrew 1 min

Motion to approve the minutes from January's meeting, with correction recommended by Don Douglass, made by Bill Daniels and seconded by Scott Peterson. With no further discussion, the motion passes by unanimous vote of all members present.

III. Treasurer's Report Roger Garcia 5 min

Account Balance – \$6,482.62

Pending 1st Quarter reimbursement, which should be received by the end of the month.

Motion to approve the treasurer's report was made by Bill Daniels and seconded by Scott Peterson. With no further discussion, the motion passes by unanimous vote of all members present.

IV. PORAC Officer's Report Tony Sanders 5 min

From PORAC Directors' Meeting in February:

PORAC is giving an active support for SB318. This bill will provide funding for COPS on the Federal Level.

PORAC is giving an active support to SB139. This legislation is for the fast tracking of DNA evidence.

PORAC is giving an active support to HR115: Thin Blue Line Act.

Bill amends the federal criminal code to expand the list of statutory aggravating factor in death penalty determinations to include the killing or attempted killing of a Law Enforcement officer, Firefighter or other first responders.

PORAC is giving an active support to HR426.

This bill will allow for the use of Military surplus again by law enforcement.

PORAC has taken an oppose position on HR158 (Corey Jones act). This bill amends the Omnibus Crime Control and Safe Streets act of 1968 to require an applicant under the Community Oriented Policing Service (COPS) program to certify that no law enforcement agency that receives COPS grant funds allow officers to conduct routine traffic stops while wearing plainclothes or while wearing plainclothes and in an unmarked police vehicle. The DOJ may not waive this "so-called" plainclothes certification requirement. If the law enforcement officer's conduct violates the plainclothes certification and results in serious injury or death of a person, then that person may bring a civil action against the law enforcement officer and any state, local or tribal government that is a COPS program grantee and has direct authority over such officer.

PORAC Active oppose to SB87: Stop Dangerous Sanctuary Cities Act. This bill prohibits a sanctuary jurisdiction from receiving grants under certain Economic Development Assistance Programs. A Sanctuary City is one that restricts information sharing about an individual's immigration status, or compliance with a lawful issue detainer request or notification of release request. Tony - While in D.C. we went to ur reps about maintaining funding for COPS programs (incl. BWC funding). There is a belief that Trump would not cut funding for COPS program, but would evveftively turn local LE into de facto immigration officers. PORAC did not feel it was fair that victims of crime may be fearful of coming forward to report crime due to immigration status.

Insurance & Benefits Bill:

PORAC I&B has asked the board to support a bill that will allow it the ability to give regional ratings to its members in a way that might bring down costs to its members. PORAC has approved support for the bill.

Bill Daniels - The way medical insurance works now, there is only one rate for all members. I&B has decided to apply for permission to give regional ratings. A bill is needed in order to accomplish this. If passed, the changes would not take

effect until 2019, but would ultimately benefit to those that are being overcharged.

PORAC active support for AB63: Driver's license provisional licenses. Will extend the age from 16 to under 21 not 18.

PORAC has decided not to contribute more money toward the Death Penalty initiative. The board reasoning is the initiative is in debt (approx \$66k) and any money we give would go towards the debt and not to furthering the cause.

Working on 2018 rates in April & May. Will be published June. Do not have members wait until Work Comp claim is denied before they put in for LTD. Claims approval is not quick so the sooner the paperwork is filed, the better. Contact Eric Swartz if you need assistance with claims. Visit website for insurance info as well as for rates on additional life insurance. \$150k policy has 98% approval rate with minimal health questions, etc.

Personal cell phone privacy / disclosure & Public Records' Act requests. Be aware / expect agencies to want to force employees to disclose photos / docs from your private cell phones and emails. A handout was presented on the issue.

Rob Wexler (RLS / SHSL)

Use of personal cell phones, along with acceptance of stipends in return, can be interpreted by courts as a tacit waiver of privacy. Three months after the RLS / SHS&L merger, things are going great. Feels like a homecoming of sorts. On a personal level we want to get out and touch bases with all of our associations. For those of you going to the negotiations table anytime soon, keep in mind recent pension adjustments with respect to expected AND actual returns. 62% of

funding for pensions comes from investments. Unfunded liabilities were expected to more than double in next five years. 1937 Act Counties are likely to follow suit.
