their craft and skills. A Real Desire will provide training at no expense to the talent if talent qualifies.

Actors

Those selected to act with A Real Desire must successfully complete at least 6 weeks of training. All actors must be at least 5 years of age and understand they will develop in areas of TV and film. In addition, actors will be given the fundamentals on projection, confidence, attitude, ethics, and other subjects to improve their craft and skills. A Real Desire will provide training at no expense to the talent if talent qualifies.

Dancers

Those selected to dance with A Real Desire must successfully complete at least 6 weeks of training. All dancers must be at least 5 years of age and understand they will develop in areas of posture and movement. In addition, dancers will be given the fundamentals on wardrobe, makeup tips, attitude, ethics, and other subjects to improve their craft and skills. A Real Desire will provide training at no expense to the talent if talent qualifies.

Training for each category of talent will be based on the level each talent displays upon being accepted. Training will be boot-camp structured to bring out the best of each person involved. - Community giveaway's

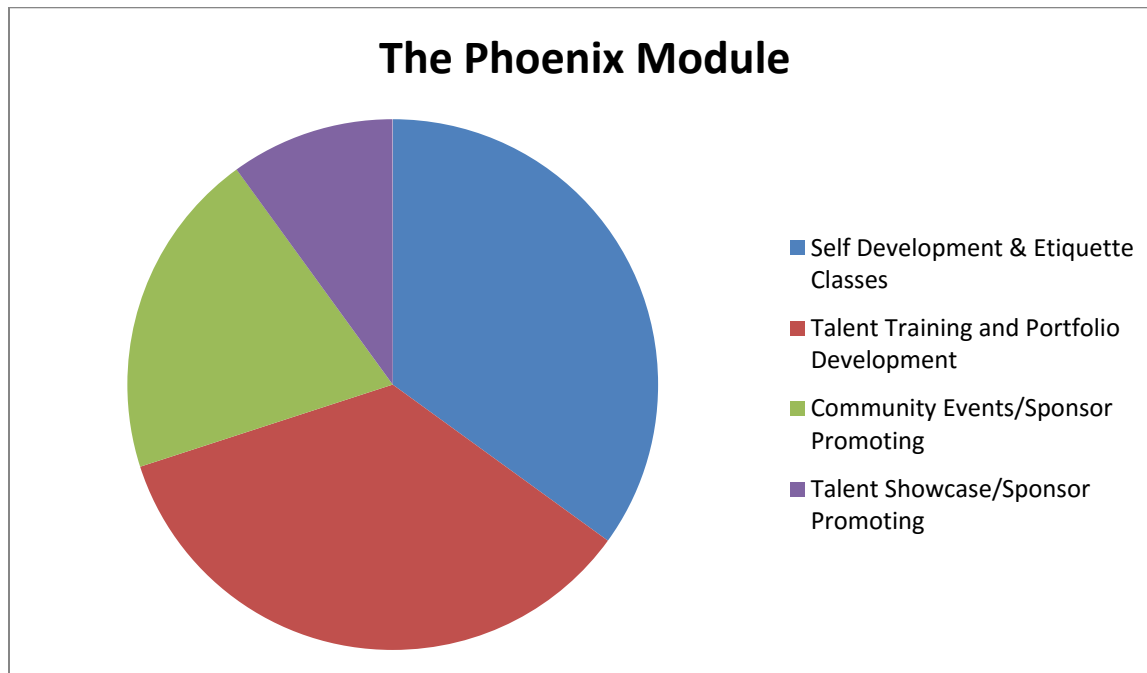

- Business operations are those tasks and activities that an organization undertakes to produce the services or goods that it provides to its customers. Efficient operations help

companies reduce costs, and they might improve customer satisfaction. Technology can be used to automate many operations and improve efficiency.

Specific business tasks can vary depending on the type of organization. For example, business operations for an insurance company might include receipt of an insurance application, underwriting, accepting or rejecting the application and claims processing. In the case of a technical support organization, they might include things such as entering a service request, resolving it, escalating it to a higher level of support or putting it on hold.

Efficiency is important for large or small business operations, because efficient operations keep expenses down. Although operations don't directly affect revenue, they do directly affect the company's cost of doing business, so operations strongly influence its ability to be profitable. Indirectly, efficient operations might enhance revenue if they increase customer satisfaction, which can help increase sales in the same city.

In exchange for a financial donation, a corporation's name and logo are included on all mailings, advertisement and other promotional material produced by the nonprofit. In some cases, a large donation may even culminated in property, such as a conference room, garden or computer laboratory being named in honor of the donating corporation.

The increase visibility of a company's name and logo leads to increased brand recognition throughout the community. An easily recognized brand makes closing sales all the more effortless. Increased sales equals increased revenue.
