Take The Safe **Seed Pledge This Spring**

Spring may still seem like a very, very long way off but - if you're a gardener - there's a good chance that thoughts of spring (and dirt and seeds) have been slowly making their way into your brain since the holidays came to a close. After all, it's not too very long from now that we ought to start planting some varieties of garden veggies and fruits indoors in preparation for spring.

But choosing the right seeds can be tough. It doesn't just come down to searching for the best variety of a crop to grow in our specific climate zone, or soil conditions, anymore. Unfortunately, it's a bit more complicated than that these days.

The big topic that seems to be gathering an increasing interest, and concern, among home gardeners these days? The issue of genetically engineered (GE) garden seeds.

You are not likely to find any garden seed company advertising the fact that their seeds have been genetically engineered. In fact, many go out of their way to assure customers that their seeds are GMO free, leading to the popular belief that the at-home gardener would be hard pressed to end up with GE seeds.

What confuses the issue is this: many of these seed companies are owned by, or affiliated with, well known companies like Monsanto or DuPont, who produce GE seed for commercial use.

As many of us know, ingredients from genetically engineered crops (also known as GMO's) have been incorporated into much of the food for sale to us in the United States. The production and consumption of GE crops is having a widespread effect on environmental and, many believe, human health.

This knowledge may leave many gardeners wondering if the seeds they have planted, or are about to plant, originated from a genetically engineered source and will therefore produce a GE crop. Unfortunately, getting to the bottom of this question is not always as simple as a yes or no.

For those of us who find this lack of information unsettling (perhaps because we would simply prefer not to give big biotech corporations our business) there are a couple simple ways to find safe, healthy, and sustainable seeds to plant this coming spring.

How? Your best bet is to look for seeds that are certified organic; these seeds must meet strict guidelines, including being free of genetic engineering, before being allowed to carry this label. Plus, if you're already planning a traditional (toxin-free) garden, why not start with an organic seed?

Looking for seed producers that have taken the Safe Seed Pledge is another helpful step. Created in 1999, hundreds of companies have now taken this pledge. It states, in part, "Agriculture and seeds provide the basis upon which our lives depend. We must protect this foundation as a safe and genetically stable source for future generations. For the benefit of all farmers, gardeners and consumers who want an alternative, we pledge that we do not knowingly buy, sell or trade genetically engineered seeds or plants."

By taking a few precautions, a gardener can feel sure that the plants they are tending are healthy, safe and sustainable. Like gardening itself, finding the right seeds isn't always going to be easy, but it will certainly be worth it
