### PROGRAM DESCRIPTION:

The Heritage Days Court is comprised of up to 4 outstanding young women who are selected from the Clatskanie community. Beginning in June, Court members travel through the end of July, visiting events, business and civic leaders, community centers, organizations and other groups. Court Members also receive one-on-one mentoring from established community leaders, enjoy complimentary outdoor group activities, and are given the chance to win a \$500 cash scholarship\*.

\*\$500 cash scholarship is awarded to the elected queen of the Heritage Days Court and is donated by the Clatskanie Chamber of Commerce.

Be Female; Attend high school; Live in ZIP code 97016; Be 16 or older; Have a minimum 2.5 cumulative GPA; Have a minimum of 10 hours community service performed throughout high school; Submit a complete application by May 7th, 2019; Attend one interview with the Court Director between May 9th and May 23rd (interview dates and times will be based on your availability).

ABOUT THE INTERVIEW PROCESS: The interview process is required for various reasons. There exist limited Member spots on the Heritage Days Court and a one-on-one with the Court Director helps both the applicant and the Director know if the commitment is a good fit. It is also important for the applicant to get as many questions answered as possible on the day of the interview. Sometimes people are better presenters than they are writers. So, this interview process insures the holistic approach of the Court's intentions by not solely relying on the application for selection. Also, at this interview, specific career interests will be uncovered so an appropriate mentorship opportunity is made if the applicant becomes a Court Member.

ABOUT TEAM-BUILDING DAYS: These days are intended for each Court Member to get better acquainted with each other and the Court Director. They are also intended to make good on the Court's promise to each member that they will receive a dignified *royal* treatment. It is the Court's intention to not charge any member for the team-building exercises. Sponsorships from local businesses are available to ensure that the cost of these days are covered.

ABOUT VOLUNTEERING AND MUSEUM TOUR: A major center of the community is the Flippin Castle Senior Center. To pay respect to the elders of the community and have easy access to the Museum during its operating hours, the Court Director has scheduled a time and day for the Court Members to serve lunch at the Senior Center.

ABOUT SPEAKING ENGAGEMENTS: A major portion of the Court includes public speaking. These speaking engagements are intended to let you network with the town's professionals, entrepreneurs, civic leaders, and volunteers. This is also an opportunity for you to learn a little more about what local organizations do and how your specific topics for discussion fit in with the values of these organizations. Below includes a list of each speaking engagement topic. More will be provided to you upon Court selection.

- June 11<sup>th</sup>: Introductions about yourself and who you are including what your goals are for your future. At this speaking engagement, you will learn about an organization known at the Columbia County Economic Team and how this organization brings together local business leaders to improve the overall economic health of the County, including Clatskanie. This group will also introduce you to the construction/plans for OMIC (Oregon Manufacturing Innovation Center).
- June 17th: Introductions about yourself and who you are including what your goals are for your future. You will also discuss what Clatskanie means to you as you present yourself in a semicasual forum with the Clatskanie Mayor, Robert Brajcich. You will learn some of the ins and outs of your local government and get to ask the Mayor questions.
- June 18<sup>th</sup>: Volunteerism and what volunteering means to you in your community will be the primary focus of this speaking engagement. You will be able to share your thoughts with the Kiwanis of Clatskanie and learn about the various roles this organization plays in the immediate community and beyond.
- June 20<sup>th</sup>: Entrepreneurship, business development, and economic growth are the topics for this speaking engagement. Here, you will have the opportunity to use some of the information you gathered on June 11<sup>th</sup> and June 17<sup>th</sup> to speak about the local economy. You will also have an opportunity at this time to personally say thank you to each of the Chamber Board Members as they are the scholarship sponsors for the Heritage Days Court. At this engagement, you will be able to learn about the Chamber's impact on the local businesses of Clatskanie.
