### A. Consider and Discuss Appointing an Interim City Manager.

Mayor Forester indicated that Finance Director, Peggy Ledbetter, has volunteered to act as Interim City Manager if that is the will of the Council.

Motion was made by Councilmember W. Johnson to appoint Peggy Ledbetter as Interim City Manager, second was made by Councilmember Bruner. Motion prevailed by the following vote:

# **B.** Consider and Discuss Authorizing a Salary Range for the City Manager Position and Potentially Directing the City Secretary to Draft and Publish an Advertisement for Position.

The Council discussed the range of salary that would be acceptable to advertise for a new City Manager and settled on \$80,000.00-\$110.000.00.

# C. Consider and Discuss and Potentially Take Action on the City's Financial Status, Responsibilities, and Plans.

Mayor Forester presented the Council with an invoice for installation of water meters that is unpaid. He further stated that the City Attorney had suggested hiring a financial advisor to assist in recovering from the budget shortfall. Mr. Jaworski spoke, saying that he felt the city should prioritize public services and presented several ideas to ease cashflow needs on the city's finances. Councilmember C. Johnson stated that he wanted an investigation of the city's finances conducted. He also said the city should institute a hiring freeze effective immediately and review the current budget for potential cuts. Interim City Manager Ledbetter requested permission to utilize funds in a water/sewer emergency fund to pay toward past due invoices and then replace the funds in November from ad valorem tax monies.

Motion was made by Councilmember C. Johnson to utilize funds in water/sewer emergency funds to pay past due invoices, second was made by Councilmember W. Johnson. Motion prevailed by the following vote:
