The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Pat Nathe, Dan Krueger, Shawn Duevel and Ron Doll were present.

On a motion by Dan Krueger, seconded by Shawn Duevel and carried the minutes from February 1st, 2016 were approved.

Fire Chief, Allen Fiedler was present and informed the Council of three medical calls last month. He also submitted a few bills that need to be paid.

On a motion by Dan Krueger, seconded by Shawn Duevel carried and approved, for \$145.00 the Fire Department will purchase two garage door openers and a key pad.

Waste/Water Operator, Tom Valerius was present and informed the council that everything is running well. He is done with the quarterly samples. The fluoride and chlorine tests are looking good. He flushed a couple of hydrants, one on Western St and one on Munich St. He would like to get well 6 up and running this month.

On a motion by Ron Doll, seconded by Dan Krueger and carried the following 3.2 Liquor License were approved, 600 Liberty St (Baseball Park) and 6th Ave E, 640 Main St (Church).

Ray Painter was present and had some questions in regards to the one-day temporary outdoor Liquor License. The City Clerk will talk to the City Attorney and will inform Ray.

Colten Wolbeck was present to inform the Council of his final design of his Eagles project for Boys Scouts. He will be designing a sign for the fire department and would like to put solar lights around the bottom. The sign will be place in front of the City Hall. Colten will be attending the planning and zoning meeting.

Ryan Vanske was present and asked the Council if he can put a well in. The City clerk informed him that he could not use it for his home. When water and sewer are available in a city a well cannot be an option. He informed the Council that on January 7th, he had rusty water and it smelled. The lines were flushed and his water was okay until the first part of March. They flushed the lines again and the water seems to be fine. Waste/water operator, Tom explained that during the cold season the lines are not flushed as often, but

will look into that for the future. Tom and Pat invited Ryan to the pump house to show him what they are doing and trying to improve the water.

Steph Boecker for R-way pumping was present to submit a snow removal bill and drop off the maps they have completed. She said that everything they have knowledge to is on the map.

On a motion by Shawn Duevel, seconded by Ron Doll and carried Resolution 3-16-A was approved.

Tom Newman was present and asked the Council if they have a price for the lot he was looking at. The Council will let him know. He also asked to get the planning and zoning ordinance emailed to him along with a zoning and flood map.

The Council will not make any decision on Shady's allege violation until they go through court.
