- All supplies will be provided for students participating in Fun-tivities.
- Class enrollment will be confirmed within one week of registration due date (**April 5, 2019**). Late registrations will only be accepted to fill vacancies. If more registrations are received than class size allows, students will be chosen at random to participate with priority going to those students who have not yet participated in a specific class. If classes are cancelled due to low enrollment, parents will be notified via email.
- Requests for withdrawal/refund must be submitted in writing seven days prior to the start of the session. Refunds will not be issued for withdrawal requests made less than seven days prior to the start of the session or after the session begins. Refunds will not be issues for missed classes.
- If it is necessary to close school for any reason, classes will be made up by adding additional dates to the end of the session. Refunds will not be issued if a student is unable to attend makeup class(es).
- Please bring a photo ID when picking up students. Only the adults listed below by the student's parent/guardian will be allowed to pick up students. Class dismissal is at 5:15pm; please arrive promptly.
- Students are expected to behave in ways that promote positivity and kindness to others. If a student is having difficulty making good choices during class, the teacher will contact parents to discuss the issue. If the behavior continues, students will be removed from the class roster. No refunds will be given for students removed from classes due to poor behavior.
- Any changes regarding dismissal/attendance should be submitted in writing to the student's teacher as well as the Fun-tivities instructor.
- Students who participate in the YMCA After School Program may enroll in Fun-tivities classes, but it is the responsibility of the parent/guardian to notify the program director of enrollment. Students will be dismissed to Y Care after class ends.
- By signing the registration form, you give permission to Fun-tivities instructors to share photos, video, and/or audio recordings taken during class in the Evans H&SA Facebook group and with professional colleagues.
