AMANA NEWS AND NOTES

Nuisances and Other Junk

Does your neighbor have junk cars in his or her yard? Or does their garbage pile up in the lawn? Do they burn it in a barrel in the backyard?

Unsightly trash, junk cars and the like: these are vexing problems for neighborhoods leading to disagreements and frustration. Over time they can affect neighborhoods and yes, lower resale home values.

While the seven Amana village are unincorporated and therefore there are no city enforced regulations, there are rules in place in Iowa County and in Amana Colonies Land Use District for dealing with issues of this nature.

At a recent social gathering the topic was discussed among Amana Colony residents who wondered, "Should one ignore or confront" neighbors who neglect or refuse to pick up? What is a nuisance and who enforces the rules?

We asked the Amana Colonies Land Use District Board of Directors for insight and received a timely response from Lynn Trumpold, longtime ACLUD director, and Richard Budde, ACLUD administrator.

Richard Budde, ACLUD administrator, said that ACLUD is working with the Iowa County Environmental Health Department officer, Sherry Lutz, to report and enforce infractions of the Iowa County nuisance ordinances. He told us, "Any resident is free to report a 'junk infraction' to the ACLUD office. It will then enter the Enforcement Activity list and be processed accordingly. Some issues can be rectified with a simple phone call."

He cited the ACLUD ordinances in place now for junk, trash/ refuse and junk vehicles. These ordinances are available for perusal on the ACLUD website under "ALCUD Zoning and Subdivision Ordinances."

According to ALCUD ordinances, in the Amana Colonies both "junk" and "junk vehicles" are not permitted. Both "junk" and "junk vehicle" are specifically defined.

As it states, "it is unlawful for any person to store, accumulate, or allow to remain on any private property within the Land Use District any junk as defined herein..." The ordinance continues, "It is hereby declared that any junk located upon private property constitutes a threat to the health and safety of the citizens and is a nuisance with the meaning of Section 657.1 of the Code of Iowa. If any junk is kept upon private property in violation hereof, the owner or person occupying the property upon which it is located shall be prima facie liable for said violation."

The provisions of this subsection do not apply to: Any junk stored within a garage or other enclosed structure.

It is unlawful for anyone to keep outside on their property "inoperable/ obsolete junk vehicles," as defined in the ACLUD ordinances. Yes, you may keep them indoors in storage, but not in your front, back or side lawn. This does not apply to vehicles actively being repaired, meaning that the vehicle has been worked on in the last 30 days.

The Iowa County Ordinance No. 30 goes further. It establishes rules on what is or is not a nuisance and what can or cannot be stored or kept on private or public property anywhere in Iowa County. That means all seven Amana villages are subject to Iowa County Ordinance No. 30.

Generally speaking, a "nuisance" is anything that is injurious to health, indecent or unreasonably offensive to the senses or an obstruction to the free use of property so as to essentially "interfere with the comfortable enjoyment of life or property." It lists specific infractions including these:

- the emission of dense smoke or noxious fumes in the burning of unauthorized material
- any condition that is conducive to the reproduction or harborage of flies, mosquitoes, rodents and other vermin
- junk motor vehicles or portions thereof located on any private or public property
- obstruction of streets, alleys, sidewalks commons, private ways so as to keep others from using these common areas or shared spaces
- an accumulation of junk or refuse
- dense weeds or vines that may constitute a

fire hazard

- and other conditions and issues.

Violations may be county infractions and result in fines for each offense, each day the violation occurs or is permitted to occur by the property owner. The Iowa County Health is authorized to issue citations in these matters.

Those Amana Colony residents who feel they have a complaint to make may contact the ACLUD office or the Iowa County Environmental Health Department Officer Sherry Lutz.

In talking with several ACLUD and county officials they noted that in many cases the best way to handle such issues is for neighbors to speak with neighbors and try to come to an amiable resolution if they can.

"In some cases neighbors may really welcome some help in cleaning up a lawn," offered Trumpold. "I know that's happened in the past where neighbors got together and worked with their neighbor."

Budde said from his perspective, "I would say that the Amana Colonies are such a close-knit community that the residents themselves should approach their neighbor and air their concerns face to face, this approach could benefit all involved parties the most."

Does Your Project Need a Permit?

Do you need to replace a fence? Rebuild a patio? Replace a window or door? Or fix up your garage or house?

Nearly all such tasks do require a permit from ACLUD. To check what's required or to apply for a permit, go to the Amana Colonies Land Use District website or stop by the office. The ACLUD office is open Tuesday and Wednesday from noon to 3 p.m. at 4304 220th Trail, in the village of Amana. Or call the office at 319-622-3840. You can also contact ACLUD Administrator Richard Budde at aclud@southslope.net.

The ACLUD website has resources about our Amana Colony historic buildings. Buildings constructed before 1932 are considered historic in the Amana Colonies and the Amana community has been working since the early 1970's to maintain, restore, rebuild and enhance the historic character of our community in keeping with our status as a National Historic Landmark.

As such many Amana property owners have made significant investments in repairing, maintaining and or restoring their historic property.

To learn how best to treat and maintain your historic property and how to enhance the character of your property go to the Amana Colonies website and look at the reference material titled, "A Conservation Handmark for Amana Villages." This book has simple drawings of fences, porches, overhangs, lanterns, sidewalk placement, windows, doors and more, plus a trove of information about historical Amana structures and their significance.
