- 1) Each candidate whose name is to appear on the ballot is unopposed;
- 2) no candidate's name is to be placed on a list of write-in candidates for the above described offices under applicable law;
- 3) no proposition will appear on the ballot

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Cisco, Texas, that based on information received and in accordance with Section 2.053, the City Council hereby authorizes the cancellation of election of Mayor for July 23, 2022, and hereby declares the unopposed candidate elected to the office, and shall be issued a certificate of election following the time the election would have been canvassed; and,

FURTHER, the City Secretary is directed to cause a copy of the Order of Cancellation, attached hereto, to be posted on election day at the polling place that would have been used in the election; and,

This resolution shall take effect upon its final passage.
