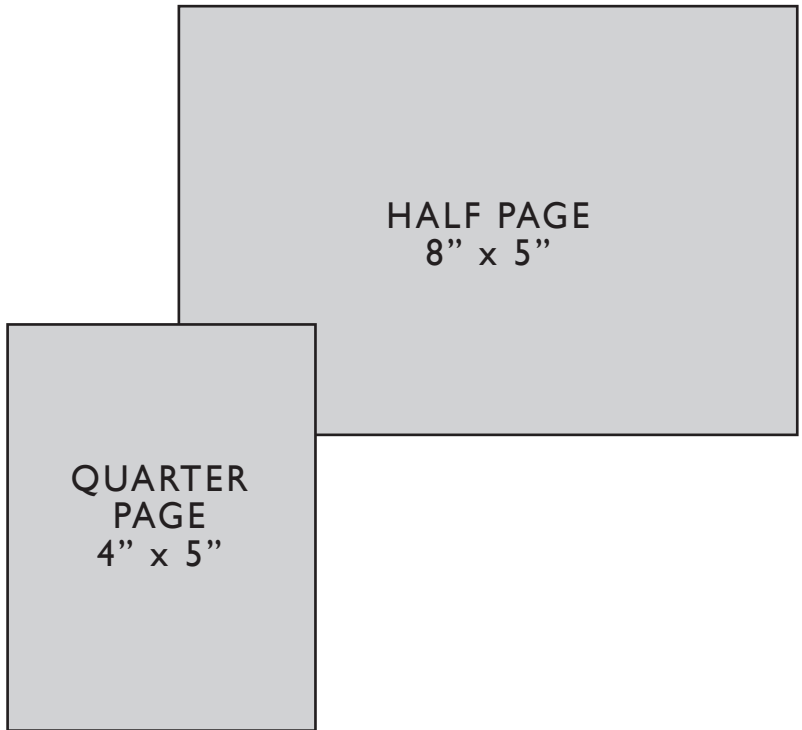

Finished sizes: Full page: 8.5 x 11
Quarter page: 4 x 5

Half page: 8 x 5

EPS • TIFF • JPEG • PDF • Quark • Indesign • Illustrator • Photoshop • Freehand • Adobe Acrobat
• Pagemaker • Corel Draw • Microsoft Publisher, Word*, Excel*, PowerPoint*

*Files submitted in these formats may incur additional charges (\$100/hr) due to special formatting required to process files.

To avoid additional charges, try creating a Press Ready PDF.

- Select Press settings when creating PDF
- Make sure that 1/8" bleed is included when creating PDF
- Embed fonts but do not Subset.

Mac or PC IMAGES can be EPS, TIFF, JPEG, PDF, BMP

- **300dpi minimum** acceptable resolution for quality printing
- **Convert all RGB images to CMYK before submitting your files...**

Not converting the color may result in undesirable color issues, as well as unwanted charges incurred to correct the problem.

- **Do not use LZW compression** when saving TIFF Files
- Make sure you throw out any Alpha Channels
- Do not embed profiles
- If sending layered PSD's with text, please send fonts as well.
- **Do not forget to add bleed** if applicable – 1/8" added to all four sides

I have included all images or all images are embedded, no links required

FONTS ... We accept all font types-

Please be sure to supply the fonts that are used in your publication.

If we have to substitute your fonts for our fonts, text may reflow and charges will be incurred to correct the problem.

I have included the fonts used in this publication or all type has been outlined, therefore no fonts are required

HARD-COPY

Please provide a print-out of your job so that we have something to check against prior to sending you a proof.

- If a printout is not received when the job is started and changes are required because of text reflow, images shifts etc., an additional charge will be incurred to correct the file.
