

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT
American Rebel Mud Park, LLC (hereinafter: ARMP)

IN CONSIDERATION OF being permitted to enter for any purpose, any AMRP Area (herein defined as including but not limited to the mud bogging areas, ponds, trail riding, motocross area, pit areas, concession area, driveway, truck bog pit, and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or any purpose participate in any way in the event. EACH OF THE UNDERSIGNED, for himself/herself, their personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he/she has or will immediately upon entering any of AMRP areas, and will continuously thereafter, respect such areas and all portions thereof which he enters and with which he comes in agreement, and he/she does further warrant that his/her entry upon such ARMP area or areas and his/her participation, if any, in the event constitutes an acknowledgement that he has understood such ARMP areas and that if, at any time, he/she is in or about ARMP Inc areas and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and will leave the ARMP Inc area and hold,(collectively, the "Releases") harmless from any and all claims or causes of action arising out of each of the undersigned.

1.) HEREBY RELEASES, WAIVES, DISCHARGES AND CONENANTS NOT TO SUE the owners, other participants, operators, officials, and any persons in any ARMP area day of event, sponsors, advertisers, and lessees of premises used to conduct the event and each of them, their officers and family, all for the purposes herein referred to as "releasees", from all liability to the undersigned, his personal representatives, assigns, heirs and next of kin for any and all loss or damage, and any claim or demands therefore or account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the ARMP area and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

2.) HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the ARMP area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releasees or otherwise.

3.) HEREBY ASSUMES FULL REPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while in or upon the ARMP area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

4.) EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities could be dangerous and involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by law of the Province or State in which the event is conducted and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in the full legal force and effect.

5.) ARMP and ATVs GONE WILD! May be filming during any events and you agree to allow your image used for any and all commercial purposes while in attendance.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representation, statements or inducements apart from the foregoing written agreement have been made.
