a APPROVE April 19, 2018 AGENDA and March 22, 2018 MEETING MINUTES Director Brinkley moved to excuse Adam Dummer's absence from the April 19, 2018 board meeting, Director Eggleston second and the motion carried unanimously. Director Miller motioned to approve the April 19, 2018 agenda and the March 22, 2018 meeting minutes, seconded by Director Eggleston and motioned carried unanimously.

10. CEO'S REPORT

The premium books are in. We received our shipment the same time as last year to the day. With the new printer, we sent the job to them on a Wednesday and they had it all done by the following Monday. As you can all see, we have a partially filled wheelbarrow full of gardening supplies that we are raffling off until June 1st. Local businesses such as Growing Wild and Bayley's Lumber have been donating items for the raffle. KIXE called, and they wanted to see if we would donate something for their televised auction coming up. It is for the KIXE wine and cheese fundraiser and we are in the process of creating a gift basket for it as well. The auction will be televised so it should be good exposure for the fair. As of right now, we have the Timberjack Lodge who donated a free night at the lodge, One Maple donated some wine and Worley Goat donated some of their cheese.

The county wide garage sale is coming up in a few weeks and we are hosting a sale in conjunction with the Trinity County Horse and Long Ears Group. We will have items that people have donated as well as a lot of stuff from around the fairgrounds that we no longer need. We even found a military diesel engine. In addition, we have a lot of farm equipment and more. It should be a good sale and possibly generate some additional funds for the fair.

I put a grant request in again this year with the Trinity Trust for \$400 which would help us buy more arts and crafts stands for the main exhibit hall. This time we might get ones that are a little larger than the ones we got last year from the same grant.

Trinity Trust also has a rapid response grant which I will try to secure to replace the heaters in the dining hall. Discussion ensued. Director Anderson mentioned that Air Quality Management offers grants to assist organizations with replacing their older tractors and other heavy machinery with cleaner and more efficient equipment.

Loren Kemper (the sound guy) will not be available for much of the summer this year due to his being on tour with Kris Kristofferson. He will be here for the fair but not too much prior to the fair. He will be busy from now until July. He will buy one guitar and Mike will donate the second guitar, Loren will have them both signed by Kris Kristofferson. We will then raffle off the first guitar and keep the second guitar in the fair office.

Mike said yes, it should replace the triple beam scale.

a DISCUSS AND/OR APPROVE CANNABIS EVENT POLICY (TABLED FROM 3/22/18 MEETING)

Director Sauer asked if we adopt the state policy, can we alter it later. Mike said we can change the policy to be a bit tougher on these types of events, but we cannot make it less strict than the state policy defines and any changes we make would need to be approved by CDFA / F&E. Discussion ensued.

Director Keys moved to adopt the state policy for cannabis events, Director Anderson seconded and the motioned passed unanimously.

15. NEW BUSINESS

a. REVIEW BAG CHECK POLICY DRAFT

Director Sauer asked if the security team will be trained by professionals. Mike replied yes, he has been talking to both Ron Hanover and Tim Saxon and they both volunteered to help train the staff. Director Sauer then asked what happens if someone wants to come into the fair with a plastic container containing water. Mike explained that staff would ask them to dump out the water and then they will immediately hand them a free bottle of water to refill their container as they enter the fair. Discussion ensued.

Director Brinkley moved to approve the bag check policy, seconded by Director Anderson and the motioned passed unanimously.
