PISTOL AND AIR RIFLE QUALIFICATION – CAVALIER RIFLE & PISTOL CLUB MONTPELIER, VA

20 Sea Cadets had to take a gun safety course before going out to the firing range. They had to pass a written test before they were allowed to handle a gun or rifle. 17 Cadets tried to qualify with 30 caliber pistols. Each had ten practice rounds at a target 30 meters from the shooting platform. After practice, each Cadet had two minutes to shoot five rounds into a target. This was done two more times. Three Cadets tried to qualify with a pellet rifle. Each had 10 practice shots at a target 30 meters from the shooting platform. Then qualification was five shots timed at three minutes a target. This was done twice more. Weather conditions were less than ideal. Freezing rain and snow made cold hands on cold steel. 🚩

On April 12, **NORTHLAND** left port in Portsmouth for an overnight shake-down cruise ahead of her upcoming Eastern Pacific patrol. Prior to the 24-HR underway stints in the Atlantic, the cutter on-loaded ammunition for the ship's MK-76 forward weapon system.

After successfully completing all drills at sea and knocking off the rust from being in port, **NORTHLAND** returned to Portsmouth.

NORTHLAND's upcoming patrol is in support of Joint Interagency Task Force South and will include enforcement of U.S. counterdrug policy as well as searching for targets of interest.

NORTHLAND headed south for its patrol area on April 18 and went straight into a gale going around Cape Hatteras. Despite the use of seasick medications, the ship was a ghost town for two days.

Later, off the coast of South Florida, **NORTHLAND** had to make an emergency stop in Port Everglades due to machinery problems.

NORTHLAND did a midnight mooring in high winds and was grateful for tugs and a local pilot. ✍

The **USS CARTER HALL (LSD-50)**, was slated for decommissioning in 2023, but instead, the ship will deploy again. When they do, CDR Brad Fancher will be the ship's Commanding Officer and CDR LaDonna Simpson will take her expertise to the Pentagon in Arlington, VA.

The **USS CARTER HALL** is one of two East Coast LSD's that is fully prepared for deployment. Months of refurbishing under former CO, CDR Matthew Shellock, and nine months of deployment under CO, LaDonna Simpson, saw this formidable Gator Freighter amass a long list of achievements, awards, recognitions, and readiness capability.

Command of the ship will change hands on Thursday, May 26, 2022, when CDR Fancher relieves CDR Simpson. CDR Fancher has a reputation for diligent preparation and the Navy needs his skills at sea. USS GRAVELLY fans,

During a scheduled port visit in Norway **USS GRAVELLY** conducted a Change of Command ceremony north of the Arctic Circle.

This time-honored tradition is a product of the rich heritage of naval tradition. Custom has established that this ceremony be formal and impressive, designed to strengthen the respect for authority vital to any organization. Parading all hands at quarters, and the public reading of official orders, stem from the days when the movement of mail and persons was a very slow process. This procedure was intended to ensure that only authorized officers held command, and that all hands were aware of the change of command.

During the ceremony, Commander Corey D. Odom was relieved by Commander Hunter D. Washburn. The Change of Command also means that **GRAVELLY** welcomes our new Executive Officer, Commander Brian C. Sanchez, aboard.

USS GRAVELLY is currently on a regularly scheduled 6th Fleet Deployment attached to Carrier Strike Group-8. The ceremony will be held as traditionally as possible, either underway on the high seas or in a scheduled port visit.

CDR Corey Odom is a native of Camden County, New Jersey and earned a Bachelor of Science degree from Old Dominion University. In addition, CDR Odom attended Johns Hopkins University where he earned a Master of Science degree and the Naval War College where he earned a Master of Arts degree. CDR Odom enlisted in the U.S. Navy in 1990, served ten years in the submarine community completing sea tours onboard **USS L. MENDEL RIVERS (SSN-686)** and **USS JACKSONVILLE (SSN-699)**. In 1999 he was accepted into the Navy's Enlisted Commissioning Program and earned his commission in 2002.

After commissioning, CDR Odom's operational assignments include command of **USS GLADIATOR (MCM 13)**,

Executive Officer in MCM CREW PERSISTENT; Weapons Officer and Combat Systems Officer in **USS OSCAR AUSTIN (DDG 79)**; Auxiliaries Officer in **USS LABOON (DDG 58)** and Strike Officer in **USS GONZALEZ (DDG 66)**. He was previously the Executive Officer of **USS GRAVELLY (DDG 107)** and assumed command of **GRAVELLY** on November 13, 2020.

Commander Odom will be relieved of duties by Commander Hunter D. Washburn. Commander Washburn is a native of Andover, Massachusetts where he graduated from Phillips Academy Andover. He attended the US Naval Academy and graduated with a degree in History. He also earned his MBA in Financial Management from the Naval Postgraduate School.

At sea, he was a plank-owner aboard **USS NITZE (DDG 94)** where he served as the Communications Officer, First Lieutenant and fleeted up to be the Navigator for her maiden deployment off the Horn of Africa. Commander Washburn was the Operations Officer aboard **USS Mahan (DDG 72)** where he deployed to the eastern Mediterranean Sea for a Ballistic Missile Defense (BMD) deployment. He commanded **USS Monsoon (PC 4)** out of Bahrain and while under his command, Monsoon was twice awarded the Battle 'E' and Marjorie Sterrett Battleship Fund Award. Commander Washburn will be fleetting up from Executive Officer to Commanding Officer.

Also joining the **GRAVELLY** Team as our new Executive Officer is Commander Brian C. Sánchez. CDR Sánchez was born in Hollywood, FL and raised in Americus, GA. CDR Sánchez graduated from the United States Naval Academy in 2006 with a Bachelor of Science in Economics.

As a division officer, CDR Sánchez sea tours include in **USS COLE (DDG 67)** as the Electrical Officer, and Riverine Squadron II Detachment II Assistant Officer-in-Charge. CDR Sánchez then served his department head tours in **USS VELLA GULF (CG 72)** as the Weapons Officer and then as Combat Systems Officer. During his time at sea he completed four deployments, and a twenty-month CNO maintenance availability.

Ashore, CDR Sánchez served in Naples, Italy on the staff of Commander Naval Forces Europe, Commander Naval Forces Africa, and Commander Sixth Fleet in the Current Operations Directorate (N33) where he was the Fleet Scheduler and Orders Production Officer during Operation ODYSSEY DAWN. CDR Sánchez graduated with distinction from the U.S. Naval War College with a Master of Arts Degree in National Security and Strategic Studies. He then served as the Flag Aide to Commander, U.S. Fleet Forces Command. Following his time as a Flag Aide, he served as Officer-in-Charge of Basic Division officer Course, Norfolk.

In all, Team **GRAVELLY** will be losing a big part of what makes us "**GRAVELLY**" with CDR Odom leaving; however, the Crew welcomes the change with open arms and bids CDR Odom "fair winds and following seas" with all of his future endeavors.
