APPLICATION FEE: Application fee to hold a MI-SHO show will be \$40.00. You do not have to send your fee in with your application, but fees must be paid thirty (30) days prior to the show date. The show fee includes database email, advertisement on the MI-SHO web page calendar and Facebook Page and inclusion in the Illinois Horse Network advertisement.

Request to hold a MI-SHO recognized show should be received by the MI-SHO secretary sixty (60) days prior to the day of the show. Any exceptions must be approved by the board. Under no circumstances will shows be granted recognition after the competition has been held.

To reserve a show date from a previous year, the show management must register the show with the MI-SHO Horse Show Secretary by **February 15**.

The show bill must state that the show is a MI-SHO recognized show. Failure to do so will result in no points being scored by the organization.

Typed or computer generated show results must be received by, or made available online, to the MISHO point secretary within twenty (20) days of the completion of the show. Results will include the class name and number, number of entries, horse's name, rider's name and age, class placement and dressage and/or CT scores, if applicable. Failure to return or make available the show results within 20 days of the completion of the show will result in a \$20.00 fine to the show management. MI-SHO will not recognize any subsequent shows held by said management until the debt is settled and show results have been received by the show secretary.

Show ring and/or hunt course must be surrounded by a suitable barrier (fence) with gate being optional. For MI-SHO recognized classes that are held after the official time of sunset lighting that provides full and complete visibility is required. This includes the show ring and all schooling/warm-up areas.

Show management must provide safe and sufficient areas for schooling and warm-up. Schooling over obstacles in the ring or over any part of the outside course is permitted only at the time designated by show management. All other schooling over obstacles will be permitted at clearly defined areas and only at times designated by show management. Schooling over obstacles in any other area of the show grounds or at any time other than what is posted is prohibited and will constitute a violation. If possible, separate schooling areas should be provided for Hunters and Jumpers if they are shown simultaneously. It is recommended that each schooling area have a minimum of two obstacles, including at least one spread fence. **SHOW MANAGEMENT HAS THE RESPONSIBILITY OF SUPERVISING THE SCHOOLING AREA AND MAINTAINING A SAFE SCHOOLING ENVIRONMENT!**
