FIGHTING FOR THE BULLYS PIT BULL RESCUE

FOSTER CONTRACT

I, _____ (herein after referred to as FOSTER FAMILY), do this ____ day of _____, _____ enter into this Foster Contract and acknowledge receipt from Fighting For The Bullys Pit Bull Rescue (herein referred to as FFTBPBR) one or more foster dogs into my home.

Throughout the adoption process, the FOSTER FAMILY understands that the dog(s) in its home will change from time to time; however, the FOSTER FAMILY agrees that this contract will never the less remain in full force and effect regardless of the dogs(s) the FOSTER FAMILY may have. Whenever the FOSTER FAMILY has any dog(s) from FFTBPBR, it agrees to fulfill the following terms and conditions to the best of its ability.

1. This Foster Contract can be amended by FFTBPBR upon giving ten (10) days written notice to the FOSTER FAMILY as needed for the best consideration of the dog(s).
2. FOSTER FAMILY agrees to notify FFTBPBR of any changes in address, phone or e-mail immediately.
3. FOSTER FAMILY agrees to return the current living foster dog(s) to FFTBPBR upon verbal or written demand by FFTBPBR. Upon the giving of such notice, FFTBPBR shall be immediately released from any and all further liability of the dog(s) to the FOSTER FAMILY or any third parties.
4. FOSTER FAMILY agrees to provide the dog(s) with a safe home, proper care and attention and humane treatment in accordance with all current and future state, county and local laws and ordinances where the FOSTER FAMILY resides. The dog(s) is not to ride loose in the back of trucks and is not to be chained or tied-out. FOSTER FAMILY warrants that the dog(s) will not be contained solely by a hidden fence. The FOSTER FAMILY agrees that when the dog(s) is outdoors it shall be accompanied by a member of the FOSTER FAMILY on a leash at ALL times.
5. FOSTER FAMILY agrees to take the dog(s) to a licensed veterinarian, as scheduled by FFTBPBR, as such appointments are made. FFTBPBR keeps all foster dog(s) under veterinary care until they are adopted.
6. FOSTER FAMILY agrees to take the dog(s) to an approved FFTBPBR licensed veterinarian to provide the dog(s) with necessary veterinary care upon emergency sickness, disease and/or injury. A list of veterinarians and emergency clinics will be given to the FOSTER FAMILY by FFTBPBR upon request. Contact must be made immediately to FFTBPBR upon any of these occurrences.
7. FOSTER FAMILY understands that there are costs involved in maintaining a dog(s) and agrees to assume full responsibility for all expenses related to food & water, flea care, grooming (after initial intake grooming) and basic health issues including administering the monthly heartworm preventative. FOSTER FAMILY understands that by assuming responsibility for these expenses, it is making a donation to FFTBPBR and is not in any way obtaining any kind of ownership interest in the dog(s).

8. AT the time the FOSTER FAMILY takes possession of the dog(s), FFTBPBR has already provided – at a minimum – the following vaccinations and tests at the intervals required by law and/or advised by their veterinarian: rabies, distemper/parvo combination, bordatella and a heartworm test followed by a regular course of preventative. However, FOSTER FAMILY agrees that they will talk to their personal vet about their fostering, and to seek advice whether he/she recommends a six-month parvo booster and/or bordatella on the family's personal pets to prevent any breakout. Regardless if FOSTER FAMILY decides to take the extra precaution with additional boosters at their expense, FFTBPBR shall not be responsible for the family pets if there is a Parvo or Bordatella outbreak in the home.
9. FOSTER FAMILY agrees that the dog(s) will reside inside his/her home and will be kept as a household pet and not be used as hunting or guard dog(s).
10. FOSTER FAMILY agrees to provide a collar and identification tag for the dog(s) to wear at all times when allowed outdoors and if provided with a FFTBPBR identification tag, which will also remain affixed to the dog(s).
11. FFTBPBR makes no warranties or representations regarding the dog(s)'s health or temperament. It is agreed and understood by the FOSTER FAMILY that while every effort is made to provide an accurate history and assessment of a dog(s), FFTBPBR does not warrant any dog(s) regarding medical status, behavior or disposition. It is further agreed that environmental changes may effect and change the temperament of the above named dog(s) and the FFTBPBR shall therefore have no liability or responsibility of any nature regarding defects with the dog(s) or injuries or damage to any person or property which may be caused for any reason by the dog(s). FOSTER FAMILY agrees to indemnify and hold harmless FFTBPBR, its members and representatives against all claims, known and unknown, now and hereafter arising in connection with this/these dog(s), including its reasonable attorney's fees and costs. **THE FOSTER FAMILY ASSUMES FULL RESPONSIBILITY FOR MAINTAINING POSITIVE CONTROL OVER THE DOG(S) AT ALL TIMES.**
12. FOSTER FAMILY consents to the examination of the dog(s) by FFTBPBR's designated agent(s) at any time without notice and acknowledges that FFTBPBR has the right to reclaim the dog(s) at any time for any reason, including, but not limited to failure to comply with the terms of this contract or for any misrepresentations of facts FOSTER FAMILY made in the Foster application or in this contract.
13. FOSTER FAMILY agrees that if for any reason, he/she cannot keep this dog(s) he/she shall immediately return it to a designated representative of FFTBPBR. The dog(s) shall not be given away, sold, exchanged, adopted or placed in any kind of animal shelter or rescue society. FFTBPBR, which may include completed paperwork for a legal adoption, the FOSTER FAMILY understands that any friend of the family or family member who wishes to take ownership of this dog(s) will be required to apply to FFTBPBR for the right to adopt and/or foster the dog(s) and that such adoption is not guaranteed.
14. If for any reason the dog(s) has not completed its medical treatments (i.e. heartworm treatment, hookworm treatment, spay, neuter, etc.) prior to the execution of this contract, FOSTER FAMILY agrees to work with FFTBPBR to attend all appointments and follow-up visits that need to be made in order to have to dog(s) healthy and ready for

adoption. FOSTER FAMILY acknowledges that FFTBPBR shall at all times have the right to and will reclaim the dog(s) if the appointments are not made.

15. FOSTER FAMILY agrees to pay FFTBPBR for any and all expenses, including court costs and reasonable attorney's fees for enforcing the terms and provisions of this contract or for any dispute arising out of this contract. Payment of these damages shall not excuse FOSTER FAMILY from returning the dog(s) to FFTBPBR and shall not constitute any kind of ownership interest in the dog(s).
16. This contract shall be construed by Tennessee law and any action arising out of or in any way related to this contract shall be brought either in the state courts located in Knox County, Tennessee or in Federal court located in the Eastern District of Tennessee, Northern Division the parties expressly agreeing to the venue and jurisdiction of such courts.
17. It is agreed and understood by FOSTER FAMILY and FFTBPBR that this written agreement sets forth all promises, agreements, conditions and understanding between them, oral and written, and that both parties have fully read and understood all of this agreement.
